# A BILL

To amend title 54, United States Code, to provide permanent, dedicated funding for the Land and Water Conservation Fund, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

### 3 SECTION 1. SHORT TITLE.

4        This Act may be cited as the “Land and Water Con-  
5 servation Fund Permanent Funding Act”.

6 SEC. 2. PERMANENT FULL FUNDING OF THE LAND AND  
7 WATER CONSERVATION FUND

8 (a) IN GENERAL.—Section 200303 of title 54, United  
9 States Code, is amended to read as follows:

1     **“§ 200303. Availability of funds**

2         “(a) IN GENERAL.—For fiscal year 2020 and each  
3         fiscal year thereafter, amounts deposited in the Fund  
4         under section 200302 shall be made available for expendi-  
5         ture, without further appropriation or fiscal year limita-  
6         tion, to carry out the purposes of the Fund (including ac-  
7         counts and programs made available from the Fund under  
8         the Consolidated and Further Continuing Appropriations  
9         Act, 2015 (Public Law 113–235; 128 Stat. 2130)).

10         “(b) ADDITIONAL AMOUNTS.—Amounts made avail-  
11         able under subsection (a) shall be in addition to amounts  
12         made available to the Fund under section 105 of the Gulf  
13         of Mexico Energy Security Act of 2006 (43 U.S.C. 1331  
14         note; Public Law 109–432) or otherwise appropriated  
15         from the Fund.

16         “(c) ALLOCATION AUTHORITY.—

17             “(1) SUBMISSION OF COST ESTIMATES.—The  
18             President shall submit to Congress detailed account,  
19             program, and project allocations to be funded under  
20             subsection (a) as part of the annual budget submis-  
21             sion of the President.

22             “(2) ALTERNATE ALLOCATION.—

23                 “(A) IN GENERAL.—Appropriations Acts  
24                 may provide for alternate allocation of amounts  
25                 made available under subsection (a), including  
26                 allocations by account and program.

## 1                   “(B) ALLOCATION BY PRESIDENT.—

## 2                   “(i) NO ALTERNATE ALLOCATIONS.—

3                   If Congress has not enacted legislation es-  
4                   tablishing alternate allocations by the date  
5                   that is 120 days after the date on which  
6                   the applicable fiscal year begins, amounts  
7                   made available under subsection (a) shall  
8                   be allocated by the President.

9                   “(ii) INSUFFICIENT ALTERNATE AL-  
10                  LOCATION.—If Congress enacts legislation  
11                  establishing alternate allocations for  
12                  amounts made available under subsection  
13                  (a) that are less than the full amount ap-  
14                  propriated under that subsection, the dif-  
15                  ference between the amount appropriated  
16                  and the alternate allocation shall be allo-  
17                  cated by the President.

## 18                  “(3) RECREATIONAL PUBLIC ACCESS.—

19                  Amounts expended from the Fund under this section  
20                  shall be consistent with the requirements for rec-  
21                  reational public access for hunting, fishing, rec-  
22                  reational shooting, or other outdoor recreational pur-  
23                  poses under section 200306(c).

24                  “(4) ANNUAL REPORT.—The President shall  
25                  submit to Congress an annual report that describes

1 the final allocation by account, program, and project  
2 of amounts made available under subsection (a), in-  
3 cluding a description of the status of obligations and  
4 expenditures.”.

5 (b) CONFORMING AMENDMENT.—Section 200302(c)  
6 of title 54, United States Code, is amended by striking  
7 paragraph (3).

8 (c) CLERICAL AMENDMENT.—The table of sections  
9 for chapter 2003 of title 54, United States Code, is  
10 amended by striking the item relating to section 200303  
11 and inserting the following:

“200303. Availability of funds.”.
