A BILL

To amend title 49, United State Code, to require small hub airports to construct areas for nursing mothers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Airport Mothers’
5 Rooms Act of 2019”.

6 **SEC. 2. MOTHERS’ ROOMS.**

7 Section 47107(w) of title 49, United States Code, is
8 amended—

9 (1) in paragraph (1) by striking “In fiscal year
10 2021” and all that follows through “the Secretary of
11 Transportation” and inserting “The Secretary of
12 Transportation”;

13 (2) in paragraph (1)(B) by striking “one men’s
14 and one women’s” and inserting “at least one men’s
15 and at least one women’s”;

16 (3) by striking paragraph (2)(A) and inserting
17 the following:

18 “(A) AIRPORT SIZE.—The requirements in
19 paragraph (1) shall only apply to applications
20 submitted by the airport sponsor of—

21 “(i) a medium or large hub airport in
22 fiscal year 2021 and each fiscal year there-
23 after; and

24 “(ii) a small hub airport in fiscal year
25 2023 and each fiscal year thereafter.”;

1 (4) in paragraph (2)(B) by striking “the date
2 of enactment of this Act complies with the require-
3 ment in paragraph (1)” and inserting “October 5,
4 2018, complies with the requirement in paragraph
5 (1)(A)”; and

6 (5) in paragraph (2)(C) by striking “paragraph
7 (1)” and inserting “paragraph (1)(A)”.
