A BILL

To authorize certain counter terrorist networks activities of U.S. Customs and Border Protection, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Counter Terrorist Net-
- 5 work Act".
- 6 SEC. 2. DUTY TO COUNTER TERRORIST NETWORKS; DE-
- 7 TAILS AND ASSIGNMENT.
- 8 Section 411 of the Homeland Security Act of 2002
- 9 (6 U.S.C. 211) is amended—
- 10 (1) in subsection (g)(4)—

| 25 | cies, including to serve overseas in support of global infor- |

- 1 mation sharing partnership operations in furtherance of
- 2 enhancing border security, including by preventing entry
- 3 into the United States by individuals known or suspected
- 4 of being associated with a network, including a foreign ter-
- 5 rorist organization (as such term is described in section
- 6 219 of the Immigration and Nationality Act (8 U.S.C.
- 7 1189)), that poses terrorist or other threats.".

8 SEC. 3. BRIEFINGS.

- 9 The Commissioner of U.S. Customs and Border Pro-
- 10 tection shall biannually brief the Committee on Homeland
- 11 Security of the House of Representatives and the Com-
- 12 mittee on Homeland Security and Governmental Affairs
- 13 of the Senate regarding activities, during the prior six
- 14 months, in furtherance of clause (vii) of section
- 15 411(g)(4)(C) of the Homeland Security Act of 2002 (6
- 16 U.S.C. 211(g)(4)(C)), as added by section 2 of this Act.
- 17 Such briefings may be provided in a classified setting if
- 18 the Commissioner determines such is appropriate.
