A BILL

To amend title 38, United States Code, to provide for limitations on copayments for contraception furnished by the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Equal Access to Contra-*
5 *ception for Veterans Act”.*

6 **SEC. 2. LIMITATION ON COPAYMENTS FOR CONTRACEP-**
7 **TION.**

8 *Section 1722A(a)(2) of title 38, United States Code,*
9 *is amended—*

10 *(1) by striking “to pay” and all that follows*
11 *through the period and inserting “to pay—”; and*

12 *(2) by adding at the end the following new sub-*
13 *paragraphs:*

14 *“(A) an amount in excess of the cost to the Sec-*
15 *retary for medication described in paragraph (1); or*

16 *“(B) an amount for any contraceptive item for*
17 *which coverage under health insurance coverage is re-*
18 *quired without the imposition of any cost-sharing re-*
19 *quirement pursuant to section 2713(a)(4) of the Pub-*
20 *lic Health Service Act (42 USC 300gg–13(a)(4)).”.*
