A BILL

To establish a grant program to assist States to establish or expand universal prekindergarten in public schools and public charter schools.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Universal Prekinder-
5 garten and Early Childhood Education Act of 2019”.

6 **SEC. 2. UNIVERSAL PREKINDERGARTEN AND EARLY**
7 **CHILDHOOD EDUCATION GRANT PROGRAM.**

8 (a) PROGRAM AUTHORIZATION.—From amounts ap-
9 propriated under section 3, the Secretary of Education is

1 authorized to award grants, on a competitive basis, to
2 States to pay the Federal share of establishing or expand-
3 ing full-day prekindergarten programs.

4 (b) STATE APPLICATION.—To receive a grant under
5 this Act, a State shall submit to the Secretary an applica-
6 tion at such time, in such manner, and containing such
7 information as the Secretary may require.

8 (c) USE OF FUNDS.—A State that receives a grant
9 under this Act shall use such grant funds to establish or
10 expand a prekindergarten program that, at a minimum—

11 (1) is located at a public school in the State;

12 (2) permits each 3- or 4-year-old child in the
13 State to be voluntarily enrolled by the child’s parent,
14 regardless of income, in the program at a school in
15 which the child may be enrolled for kindergarten;

16 (3) is a full-day program that runs the length
17 of the regular school year;

18 (4) is taught by teachers who possess equivalent
19 or similar qualifications to the qualifications of
20 teachers of other grades in the school involved; and

21 (5) meets any other criteria that the Secretary
22 may require.

23 (d) FEDERAL SHARE.—The Federal share of a grant
24 under this Act shall be not more than 80 percent of the

1 costs of carrying out the activities described in subsection
2 (c).

3 (e) SUPPLEMENT NOT SUPPLANT.—Grant funds re-
4 ceived under this Act shall be used to supplement and not
5 supplant other Federal early childhood education funds in
6 the State.

7 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

8 There are authorized to be appropriated to carry out
9 this Act such sums as are necessary for fiscal years 2020
10 through 2025.

11 **SEC. 4. DEFINITIONS.**

12 In this Act:

13 (1) FULL-DAY.—The term “full-day” used with
14 respect to a program, means a program with a min-
15 imum of a 6-hour schedule per day.

16 (2) SECRETARY.—The term “Secretary” means
17 the Secretary of Education.

18 (3) STATE.—The term “State” has the mean-
19 ing given the term in section 8101 of the Elemen-
20 tary and Secondary Education Act of 1965 (20
21 U.S.C. 7801).

22 (4) PARENT.—The term “parent” has the
23 meaning given the term in section 8101 of the Ele-
24 mentary and Secondary Education Act of 1965 (20
25 U.S.C. 7801).

1 (5) PUBLIC SCHOOL.—The term “public
2 school” has the meaning given the term “elementary
3 school” or “secondary school” in section 8101 of the
4 Elementary and Secondary Education Act of 1965
5 (20 U.S.C. 7801), except that the term does not in-
6 clude private schools.
