- 3 (a) In General.—Not later than 120 days after the
- 4 date of the enactment of this Act, the Under Secretary
- 5 of Homeland Security for Intelligence and Analysis, as au-
- 6 thorized by section 201(b)(1) of the Homeland Security
- 7 Act of 2002 (6 U.S.C. 121(b)(1)), shall, in coordination
- 8 with appropriate Federal partners, develop and dissemi-
- 9 nate a threat assessment regarding the actual and poten-
- 10 tial threat posed by individuals using virtual currency to
- 11 carry out activities in furtherance of an act of terrorism,
- 12 including the provision of material support or resources
- 13 to a foreign terrorist organization. Consistent with the
- 14 protection of classified and confidential unclassified infor-
- 15 mation, the Under Secretary shall share the threat assess-
- 16 ment developed under this section with State, local, and
- 17 tribal law enforcement officials, including officials who op-
- 18 erate within State, local, and regional fusion centers
- 19 through the Department of Homeland Security State,
- 20 Local, and Regional Fusion Center Initiative established
- 21 in section 210A of the Homeland Security Act of 2002

- 23 (b) Definitions.—In this section:
- 24 (1) The term "foreign terrorist organization"
- 25 means an organization designated as a foreign ter-

- 1 rorist organization under section 219 of the Immi-2 gration and Nationality Act (8 U.S.C. 1189).
- 3 (2) The term "virtual currency" means a digital 4 representation of value that functions as a medium 5 of exchange, a unit of account, or a store of value.
