A BILL

To amend title 10, United States Code, to authorize the Secretary of Defense to appoint officers of the Armed Forces as directors of medical centers of the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REORGANIZATION OF DEPARTMENT OF VET-**
2 **ERANS AFFAIRS MEDICAL CENTER DIREC-**
3 **TORS.**

4 (a) REORGANIZATION.—Chapter 55 of title 10,
5 United States Code, is amended by inserting after section
6 1104 the following new section:

7 **“§ 1104a. Appointment of directors of medical centers**
8 **of the Department of Veterans Affairs**

9 “(a) APPOINTMENT BY SECRETARY OF DEFENSE.—
10 The Secretary of Defense shall appoint the director of
11 each medical center of the Department of Veterans Af-
12 fairs.

13 “(b) QUALIFICATIONS.—The Secretary of Defense, in
14 consultation with the Secretaries of the military depart-
15 ments, shall establish the common qualifications and core
16 competencies required for an officer of the armed forces
17 to serve as a director under this section.

18 “(c) FUNCTIONS AND RESPONSIBILITIES.—Each di-
19 rector under this section shall have the functions and re-
20 sponsibilities of a director of a medical center of the De-
21 partment of Veterans Affairs under title 38, and any other
22 functions or responsibilities as the Secretary of Defense
23 may assign.

24 “(d) TRAINING OF OFFICERS.—The Secretary of De-
25 fense shall provide training to officers of the armed forces
26 to serve as directors under this section through the joint

1 medical executive skills development program established
 2 under Department of Defense Instruction 6000.15 (or any
 3 successor instruction).”.

4 (b) CONFORMING AMENDMENTS.—

5 (1) TITLE 38.—Title 38, United States Code, is
 6 amended—

7 (A) in section 7401(4), by striking “Direc-
 8 tors of medical centers and directors” and in-
 9 serting “Directors”; and

10 (B) in section 7402(b), by striking “Cen-
 11 ter,” in the heading of paragraph (4).

12 (2) VA CHOICE AND QUALITY EMPLOYMENT
 13 ACT OF 2017.—Section 210 of the VA Choice and
 14 Quality Employment Act of 2017 (Public Law 115–
 15 46; 131 Stat. 965; 38 U.S.C. 7401 note) is repealed.

16 (c) CLERICAL AMENDMENT.—The table of sections
 17 at the beginning of chapter 55 of title 10, United States
 18 Code, is amended by inserting after the item relating to
 19 section 1104 the following new item:

“1104a. Appointment of directors of medical centers of the Department of Vet-
 erans Affairs.”.

20 (d) EFFECTIVE DATE.—This Act and the amend-
 21 ments made by this Act shall apply with respect to a direc-
 22 tor of a medical center of the Department of Veterans Af-

- 1 fairs appointed on or after the date of the enactment of
- 2 this Act.
