A BILL

To amend title XVIII of the Social Security Act to provide coverage for certain vision items and services under part B of the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Medicare Vision Act of*
 5 *2019”.*

6 **SEC. 2. PROVIDING COVERAGE FOR VISION CARE UNDER**
 7 **THE MEDICARE PROGRAM.**

8 *(a) COVERAGE.—Section 1861(s)(2) of the Social Secu-*
 9 *rity Act (42 U.S.C. 1395x(s)(2)) is amended—*

10 *(1) in subparagraph (GG), by striking “and”*
 11 *after the semicolon at the end;*

12 *(2) in subparagraph (HH), by striking the pe-*
 13 *riod at the end and adding “; and”; and*

14 *(3) by adding at the end the following new sub-*
 15 *paragraph:*

16 *“(II) vision services (as defined in subsection*
 17 *(kkk));”.*

18 *(b) VISION SERVICES DEFINED.—Section 1861 of the*
 19 *Social Security Act (42 U.S.C. 1395x) is amended by add-*
 20 *ing at the end the following new subsection:*

21 *“(kkk) VISION SERVICES.—The term ‘vision services’*
 22 *means—*

23 *“(1) routine eye examinations to determine the*
 24 *refractive state of the eyes, including procedures per-*
 25 *formed during the course of such examination; and*

1 “(2) *contact lens fitting services;*
 2 *furnished on or after January 1, 2022, by or under the di-*
 3 *rect supervision of an optometrist or ophthalmologist who*
 4 *is legally authorized to furnish such examinations, proce-*
 5 *dures, or fitting services (as applicable) under State law*
 6 *(or the State regulatory mechanism provided by State law)*
 7 *of the State in which the examinations, procedures, or fit-*
 8 *ting services are furnished.”.*

9 (c) *PAYMENT; COINSURANCE; AND LIMITATIONS.—*

10 (1) *IN GENERAL.—Section 1833(a)(1) of the So-*
 11 *cial Security Act (42 U.S.C. 1395l(a)(1)) is amend-*
 12 *ed—*

13 (A) *by striking “and” before “(CC)”;* and

14 (B) *by inserting before the semicolon at the*
 15 *end the following: “, and (DD) with respect to*
 16 *vision services (as defined in section 1861(kkk)),*
 17 *the amount paid shall be equal to 80 percent of*
 18 *the lesser of the actual charge or the amount de-*
 19 *termined under the payment basis determined*
 20 *under section 1848”.*

21 (2) *LIMITS SPECIFIED.—Section 1834 of the So-*
 22 *cial Security Act (42 U.S.C. 1395m) is amended by*
 23 *adding at the end the following new subsection:*

24 “(x) *LIMITATION FOR VISION SERVICES.—With respect*
 25 *to vision services (as defined in section 1861(kkk)) and an*

1 *individual, payment may be made under this part for only*
 2 *1 routine eye examination described in paragraph (1) of*
 3 *such section and 1 contact lens fitting service described in*
 4 *paragraph (2) of such section during a 2-year period.”.*

5 *(d) PAYMENT UNDER PHYSICIAN FEE SCHEDULE.—*

6 *(1) IN GENERAL.—Section 1848(j)(3) of the So-*
 7 *cial Security Act (42 U.S.C. 1395w-4(j)(3)) is*
 8 *amended by inserting “(2)(II),” before “(3)”.*

9 *(2) BUDGET NEUTRALITY.—Section*
 10 *1848(c)(2)(B)(iv) of the Social Security Act (42*
 11 *U.S.C. 1395-w(c)(2)(B)(iv)) is amended—*

12 *(A) in subclause (III), by striking “and” at*
 13 *the end;*

14 *(B) in subclause (IV), by striking the period*
 15 *at the end and inserting “; and”; and*

16 *(C) by adding at the end the following new*
 17 *subclause:*

18 *“(V) the amendment made by sec-*
 19 *tion 2(d)(1) of the Medicare Vision Act*
 20 *of 2019 shall not be taken into account*
 21 *in applying clause (ii)(II) for 2022*
 22 *and 2023.”.*

23 *(e) COVERAGE OF CONVENTIONAL EYEGLASSES AND*
 24 *CONTACT LENSES.—Section 1861(s)(8) of the Social Secu-*
 25 *rity Act (42 U.S.C. 1395x(s)(8)) is amended by striking “,*

1 *and including one pair of conventional eyeglasses or contact*
 2 *lenses furnished subsequent to each cataract surgery with*
 3 *insertion of an intraocular lens” and inserting “, including*
 4 *one pair of conventional eyeglasses or contact lenses fur-*
 5 *nished subsequent to each cataract surgery with insertion*
 6 *of an intraocular lens, if furnished before January 1, 2022,*
 7 *and including conventional eyeglasses or contact lenses,*
 8 *whether or not furnished subsequent to such a surgery, if*
 9 *furnished on or after January 1, 2022”.*

10 (f) *SPECIAL PAYMENT RULES FOR EYEGLASSES AND*
 11 *CONTACT LENSES.—*

12 (1) *LIMITATIONS.—Section 1834(h) of the Social*
 13 *Security Act (42 U.S.C. 1395m(h)) is amended by*
 14 *adding at the end the following new paragraph:*

15 “(6) *PAYMENT LIMITATIONS FOR EYEGLASSES*
 16 *AND CONTACT LENSES.—*

17 “(A) *IN GENERAL.—With respect to eye-*
 18 *glasses and contact lenses furnished to an indi-*
 19 *vidual on or after January 1, 2022, subject to*
 20 *subparagraph (B), payment may be made under*
 21 *this part only—*

22 “(i) *during a 2-year period, for either*
 23 *1 pair of eyeglasses (including lenses and*
 24 *frames) or a 2-year supply that is provided*

1 *in not more than 180-day increments of*
2 *contact lenses;*

3 “(ii) *with respect to amounts attrib-*
4 *utable to the frames of such a pair of eye-*
5 *glasses and amounts attributable to contact*
6 *lenses furnished during a year, in an*
7 *amount not greater than—*

8 “(I) *for 2022, \$100; and*

9 “(II) *for a subsequent year, the*
10 *amount specified under this subpara-*
11 *graph for the previous year, increased*
12 *by the percentage change in the con-*
13 *sumer price index for all urban con-*
14 *sumers during such previous year;*

15 “(iii) *for types of eyeglass lenses, and*
16 *for types of contact lenses, as determined*
17 *appropriate by the Secretary;*

18 “(iv) *if furnished pursuant to a writ-*
19 *ten order of a physician described in section*
20 *1861(kkk); and*

21 “(v) *if during the 2-year period de-*
22 *scribed in clause (i), the individual did not*
23 *already receive (as described in subpara-*
24 *graph (B)) one pair of conventional eye-*
25 *glasses or contact lenses subsequent to a cat-*

aract surgery with insertion of an intra-
ocular lens furnished during such period.

“(B) *EXCEPTION.*—With respect to a 2-year
period described in subparagraph (A)(i), in the
case of an individual who receives cataract sur-
gery with insertion of an intraocular lens, not-
withstanding subparagraph (A), payment may
be made under this part for one pair of conven-
tional eyeglasses or contact lenses furnished sub-
sequent to such cataract surgery during such pe-
riod.”.

(2) *APPLICATION OF COMPETITIVE ACQUISI-
TION.*—

(A) *IN GENERAL.*—Section 1834(h)(1)(H) of
the Social Security Act (42 U.S.C.
1395m(h)(1)(H)) is amended—

(i) in the header by inserting “, EYE-
GLASSES, AND CONTACT LENSES” after
“ORTHOTICS”;

(ii) by inserting “and of eyeglasses and
contact lenses described in paragraph
(2)(D) of such section,” after “2009,” ; and

(iii) in clause (i), by inserting “or
such eyeglasses and contact lenses” after
“orthotics”.

1 (B) CONFORMING AMENDMENT.—

2 (i) IN GENERAL.—Section 1847(a)(2)
 3 of the Social Security Act (42 U.S.C.
 4 1395w–3(a)(2)) is amended by adding at
 5 the end the following new subparagraph:

6 “(D) EYEGLASSES AND CONTACT LENSES.—
 7 Eyeglasses and contact lenses for which payment
 8 would otherwise be made under section
 9 1834(h).”.

10 (ii) EXEMPTION OF CERTAIN ITEMS
 11 FROM COMPETITIVE ACQUISITION.—Section
 12 1847(a)(7) of the Social Security Act (42
 13 U.S.C. 1395w–3(a)(7)) is amended by add-
 14 ing at the end the following new subpara-
 15 graph:

16 “(C) CERTAIN EYEGLASSES AND CONTACT
 17 LENSES.—Those items and services described in
 18 paragraph (2)(D) if furnished by a physician or
 19 other practitioner (as defined by the Secretary)
 20 to the physician’s or practitioner’s own patients
 21 as part of the physician’s or practitioner’s pro-
 22 fessional service.”.

23 (g) EXCLUSION MODIFICATIONS.—Section 1862(a) of
 24 the Social Security Act (42 U.S.C. 1395y(a)) is amended—
 25 (1) in paragraph (1)—

1 (A) in subparagraph (O), by striking “and”
2 at the end;

3 (B) in subparagraph (P), by striking the
4 semicolon at the end and inserting “, and”; and

5 (C) by adding at the end the following new
6 subparagraph:

7 “(Q) in the case of vision services (as defined in
8 section 1861(kkk)) that are routine eye examinations
9 and contact lens fitting services (as described in para-
10 graph (1) or (2), respectively, of such section), which
11 are furnished more frequently than once during a 2-
12 year period;”; and

13 (2) in paragraph (7)—

14 (A) by inserting “(other than such an exam-
15 ination that is a vision service that is covered
16 under section 1861(s)(2)(II))” after “eye exami-
17 nations”; and

18 (B) by inserting “(other than such a proce-
19 dure that is a vision service that is covered
20 under section 1861(s)(2)(II))” after “refractive
21 state of the eyes”.

22 **SEC. 3. IMPLEMENTATION FUNDING.**

23 The Secretary of Health and Human Services shall
24 provide for the transfer from the Federal Supplementary
25 Medical Insurance Trust Fund under section 1841 of the

1 *Social Security Act (42 U.S.C. 1395t) to the Centers for*
2 *Medicare & Medicaid Services Program Management Ac-*
3 *count for the period of 2020 through 2024 of such sums as*
4 *may be necessary for purposes of implementing the amend-*
5 *ments made by section 2.*
