A BILL

To prohibit the Secretary of Homeland Security from operating or procuring foreign-made unmanned aircraft systems, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Drone Origin Security
5 Enhancement Act”.

6 **SEC. 2. PROHIBITION ON OPERATION OR PROCUREMENT**
7 **OF FOREIGN-MADE UNMANNED AIRCRAFT**
8 **SYSTEMS.**

9 (a) PROHIBITION ON AGENCY OPERATION OR PRO-
10 CUREMENT.—The Secretary of Homeland Security may
11 not operate, provide financial assistance for, or enter into
12 or renew a contract for the procurement of—

13 (1) an unmanned aircraft system (UAS) that—

14 (A) is manufactured in a covered foreign
15 country or by a corporation domiciled in a cov-
16 ered foreign country;

17 (B) uses flight controllers, radios, data
18 transmission devices, cameras, or gimbals man-
19 ufactured in a covered foreign country or by a
20 corporation domiciled in a covered foreign coun-
21 try;

22 (C) uses a ground control system or oper-
23 ating software developed in a covered foreign
24 country or by a corporation domiciled in a cov-
25 ered foreign country; or

1 (D) uses network connectivity or data stor-
2 age located in or administered by a corporation
3 domiciled in a covered foreign country; or

4 (2) a system manufactured in a covered foreign
5 country or by a corporation domiciled in a covered
6 foreign country for the detection or identification of
7 covered unmanned aircraft systems.

8 (b) WAIVER.—The Secretary of Homeland Security
9 may waive the prohibition under subsection (a) on a case
10 by case basis by certifying in writing to the Committee
11 on Homeland Security of the House of Representatives
12 and the Committee on Homeland Security and Govern-
13 mental Affairs of the Senate that the operation or procure-
14 ment that is the subject of such a waiver is required—

15 (1) in the national interest of the United
16 States;

17 (2) for counter-UAS surrogate testing and
18 training; or

19 (3) for intelligence, electronic warfare, or infor-
20 mation warfare operations, testing, analysis, and or
21 training.

22 (c) DEFINITIONS.—In this section:

23 (1) COVERED FOREIGN COUNTRY.—The term
24 “covered foreign country” means a country labeled
25 as a strategic competitor in the “Summary of the

1 2018 National Defense Strategy of the United
2 States of America: Sharpening the American Mili-
3 tary’s Competitive Edge” issued by the Department
4 of Defense pursuant to section 113 of title 10,
5 United States Code.

6 (2) COVERED UNMANNED AIRCRAFT SYSTEM.—
7 The term “unmanned aircraft system” has the
8 meaning given such term in section 331 of the FAA
9 Modernization and Reform Act of 2012 (Public Law
10 112–95; 49 U.S.C. 44802 note).
