A BILL

To extend the Undertaking Spam, Spyware, And Fraud Enforcement With Enforcers beyond Borders Act of 2006, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF THE U.S. SAFE WEB ACT OF 2006.**

4 Section 13 of the U.S. SAFE WEB Act of 2006
5 (Public Law 109–455; 15 U.S.C. 44 note) is amended by
6 striking “September 30, 2020” and inserting “September
7 30, 2027”.

8 **SEC. 2. REPORT.**

9 Not later than 3 years after the date of the enact-
10 ment of this Act, the Federal Trade Commission shall
11 transmit to the Committee on Energy and Commerce of
12 the House of Representatives and the Committee on Com-
13 merce, Science, and Transportation of the Senate a report
14 describing its use of and experience with the authority
15 granted by the U.S. SAFE WEB Act of 2006 (Public Law
16 109–455) and the amendments made by such Act. The
17 report shall include—

18 (1) the number of cross-border complaints re-
19 ceived and acted upon by the Commission;

20 (2) identification of the foreign agencies with
21 which the Commission has cooperated and the re-
22 sults of such cooperation, including any foreign
23 agency enforcement action or lack thereof;

1 (3) a description of Commission litigation
2 brought in foreign courts and the results of such liti-
3 gation; and

4 (4) any recommendations for legislation that
5 may advance the mission of the Commission in car-
6 rying out the U.S. SAFE WEB Act of 2006 and the
7 amendments made by such Act.
