A BILL

To redesignate the NASA John H. Glenn Research Center at Plum Brook Station, Ohio, as the NASA John H. Glenn Research Center at the Neil A. Armstrong Test Facility.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Neil A. Armstrong
5 Test Facility Act”.

1 **SEC. 2. FINDINGS.**

2 Congress finds as follows:

3 (1) Neil A. Armstrong, through his own defini-
4 tion, was first and foremost a test pilot.

5 (2) A native of Wapakoneta, Ohio, Armstrong
6 began his inspiring career in space exploration in
7 Cleveland, Ohio, at what is now the NASA John H.
8 Glenn Research Center.

9 (3) Becoming the first human to land a space-
10 craft, and then set foot upon the moon, represents
11 the greatest dream of any test pilot.

12 (4) Therefore, it is fitting that the premier aer-
13 onautics and space test station in Ohio should be re-
14 named in his honor.

15 **SEC. 3. REDESIGNATION OF NASA JOHN H. GLENN RE-**
16 **SEARCH CENTER AT PLUM BROOK STATION,**
17 **OHIO, AS NASA JOHN H. GLENN RESEARCH**
18 **CENTER AT THE NEIL A. ARMSTRONG TEST**
19 **FACILITY.**

20 (a) REDESIGNATION.—The NASA John H. Glenn
21 Research Center at Plum Brook Station, Ohio, is hereby
22 redesignated as the NASA John H. Glenn Research Cen-
23 ter at the Neil A. Armstrong Test Facility.

24 (b) REFERENCES.—Any reference in a law, map, reg-
25 ulation, document, paper, or other record of the United
26 States to the station referred to in subsection (a) shall

1 be deemed to be a reference to the “NASA John H. Glenn
2 Center at the Neil A. Armstrong Test Facility”.

3 (c) SAVINGS.—Nothing in this section shall be con-
4 strued to alter the relationship between the Plum Brook
5 Station and the NASA John H. Glenn Research Center.
