- To facilitate the automatic acquisition of citizenship for lawful permanent resident children of military and Federal Government personnel residing abroad, and for other purposes.
- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Citizenship for Chil-3 dren of Military Members and Civil Servants Act".

4 SEC. 2. FACILITATING THE AUTOMATIC ACQUISITION OF
5 CITIZENSHIP FOR LAWFUL PERMANENT
6 RESIDENT CHILDREN OF MILITARY AND FED7 ERAL GOVERNMENT PERSONNEL RESIDING
8 ABROAD.

9 (a) IN GENERAL.—Section 320 of the Immigration
10 and Nationality Act (8 U.S.C. 1431) is amended—

(1) by striking the section header and inserting
"CHILDREN BORN OUTSIDE THE UNITED STATES
AND LAWFULLY ADMITTED FOR PERMANENT RESIDENCE; CONDITIONS UNDER WHICH CITIZENSHIP
AUTOMATICALLY ACQUIRED";

16 (2) by redesignating subsection (c) as sub-17 section (d); and

18 (3) by inserting after subsection (b) the fol-19 lowing:

20 "(c) Subsection (a)(3) is deemed satisfied in the case
21 of a child who is lawfully admitted for permanent resi22 dence in the United States if—

23 "(1) the child is residing in the legal and phys24 ical custody of a citizen parent who is—

1	"(A) stationed and residing abroad as an
2	employee of the Government of the United

4	"(B) residing abroad in marital union with
5	an employee of the Government of the United
6	States who is stationed abroad; or
7	"(2) the child is—

9	tody of a citizen parent who is—
10	"(i) stationed and residing abroad as
11	a member of the Armed Forces of the
12	United States; or
13	"(ii) authorized to accompany and re-
14	side abroad with a member of the Armed
15	Forces of the United States pursuant to
16	the member's official orders, and is so ac-
17	companying and residing abroad with the
18	member in marital union; and
19	"(B) authorized to accompany such mem-
20	ber and reside abroad with the member pursu-
21	ant to the member's official orders, and is so
22	accompanying and residing with the member.".
23	(b) Conforming Amendment.—The table of con-
24	tents for the Immigration and Nationality Act is amended

1 by striking the item relating to section 320 and inserting

2 the following:

3 SEC. 3. DETERMINATION OF BUDGETARY EFFECTS.
