A BILL

To amend title 37, United States Code, to provide for the continuance of pay and allowances for members of the Armed Forces, including reserve components thereof, during lapses in appropriations.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Armed Services Always
- 5 Paid Act" or the "ASAP Act".

| 10 | "(1) The term 'military personnel accounts' |

| 14 | partment of Defense appropriations Act, and the |
| 15 | corresponding accounts for the Department of |

| 18 | "(2) The term 'pay and allowances' means |
| 19 | basic pay, bonuses and special pay, allowances and |
| 20 | any other forms of compensation available for mem- |
| 21 | bers of the armed forces under this title or otherwise |
| 22 | paid from the military personnel accounts. |
| 23 | "(3) The term 'period of lapsed appropriations', |
| 24 | when used with respect to members of the armed |
| 25 | forces, means any period during which appropria- |
| 26 | tions are not available due to the absence of the |

- 2 cluding any Act or joint resolution making con-
- 3 tinuing appropriations) appropriating funds for the

- 6 "(b) Appropriation of Funds To Continue Pay-
- 7 MENT OF PAY AND ALLOWANCES.—For any period of
- 8 lapsed appropriations, there are appropriated, out of any
- 9 moneys in the Treasury not otherwise appropriated, to the
- 10 Secretary of Defense (and the Secretary of Homeland Se-
- 11 curity in the case of the Coast Guard) to allow the Sec-
- 12 retary of Defense (and the Secretary of Homeland Secu-
- 13 rity in the case of the Coast Guard) to continue to provide
- 14 pay and allowances (without interruption) to members of
- 15 the United States armed forces.
- 16 "(c) Limitation on Amounts Paid.—This section
- 17 only authorizes the expenditure of funds during a period
- 18 of lapsed appropriations for the pay and allowances of a
- 19 member of the armed forces at a rate that is equal to the
- 20 rate in effect for that member immediately before the start
- 21 of the period of lapsed appropriations. The rate for a
- 22 member may neither exceed the rate in effect immediately
- 23 before the start of the period of lapsed appropriations nor
- 24 be less than that rate, unless reduced by disciplinary ac-
- 25 tion under the Uniform Code of Military Justice.

- 1 "(d) Relation to Other Pay Authorities.—This
- 2 section shall not be construed to affect the entitlement of
- 3 a member of the armed forces to an amount of pay and
- 4 allowances that exceeds the amount of pay and allowances
- 5 authorized to be paid under this section and to which the
- 6 member becomes entitled under other applicable provisions
- 7 of law.
- 8 "(e) Effect of End of Period of Lapsed Ap-
- 9 PROPRIATIONS.—Expenditures made for any fiscal year
- 10 pursuant to this section shall be charged to the applicable
- 11 appropriation, fund, or authorization whenever the regular
- 12 appropriation bill (or other bill or joint resolution making
- 13 continuing appropriations through the end of the fiscal
- 14 year) becomes law.".
- 15 (b) Clerical Amendment.—The table of sections
- 16 at the beginning of such chapter is amended by adding
- 17 at the end the following new item:

"1016. Continuance of pay and allowances during periods of lapsed appropriations.".
