## A BILL

To name the Department of Veterans Affairs community-based outpatient clinic in Youngstown, Ohio, as the “Carl Nunziato VA Clinic”.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. FINDINGS.**

4       Congress makes the following findings:

5               (1) Carl Nunziato graduated from Youngstown  
6       State University ROTC as the Distinguished Military  
7       Graduate in 1961 and commissioned into the  
8       U.S. Army.

1           (2) While serving, Major (ret.) Nunziato was  
2 stationed in Thailand during the Laotian Crisis.  
3 Major Nunziato later served two voluntary tours of  
4 combat duty in Vietnam.

5           (3) On his second tour, then-Captain Nunziato  
6 was severely injured, losing both legs from a mortar  
7 attack while protecting a small Vietnamese village in  
8 Soui Da.

9           (4) Major Nunziato spent two years at Walter  
10 Reed Military Hospital recovering from his wounds.  
11 He then returned home to Northeastern Ohio where  
12 he enrolled in Case Western University Law School  
13 earning a degree in 1971. Following retirement from  
14 active duty, Major Nunziato continuously cham-  
15 pioned the rights of veterans and the disabled, while  
16 establishing a distinguished career in banking and  
17 finance.

18           (5) Due to Major Nunziato's tireless efforts, a  
19 Department of Veterans Affairs outpatient clinic  
20 was established in Youngstown. Additionally, his ex-  
21 haustive work throughout Mahoning County has  
22 brought curb cuts, wheel chair ramps and other ac-  
23 cessibility measures to county public buildings, uni-  
24 versities and courthouses, affording more independ-  
25 ence to local disabled population. These efforts were

1 borne from witnessing fellow disabled veterans de-  
2 nied justice and equality, after having fought and  
3 sacrificed for those same principles.

4 **SEC. 2. NAME OF DEPARTMENT OF VETERANS AFFAIRS**  
5 **COMMUNITY-BASED OUTPATIENT CLINIC,**  
6 **YOUNGSTOWN, OHIO.**

7 The Department of Veterans Affairs community-  
8 based outpatient clinic in Youngstown, Ohio, shall, after  
9 the date of the enactment of this Act, be known and des-  
10 ignated as the “Carl Nunziato VA Clinic”. Any reference  
11 to such clinic in any law, regulation, map, document,  
12 record, or other paper of the United States shall be consid-  
13 ered to be a reference to the Carl Nunziato VA Clinic.
