## A BILL

To require the Attorney General to establish a grant program to assist with the medical expenses of qualified working dogs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “K–9 Hero Act of  
5 2019”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1           (1) On October 27, 2019, United States special  
2 operations forces carried out a raid, which resulted  
3 in the death of ISIS leader Abu Bakr al-Baghdadi.

4           (2) A military working dog, whose identity is  
5 classified, played an integral role in the success of  
6 the raid and kept United States military personnel  
7 out of harm's way.

8           (3) Although injured during the raid, the mili-  
9 tary working dog is recovering and continues to  
10 serve heroically alongside his handler in theater.

11           (4) Working dogs, such as the one involved in  
12 the Al-Baghdadi raid, play a critical role in assisting  
13 our Armed Forces and Federal and local law en-  
14 forcement in protecting Americans and defending  
15 freedom at home and abroad.

16           (5) Within the Federal Government, working  
17 dogs assist the U.S. Capitol Police, the Bureau of  
18 Alcohol, Tobacco, Firearms and Explosives, the  
19 Transportation Security Administration, the Depart-  
20 ment of Defense, U.S. Customs and Border Protec-  
21 tion, and the Federal Bureau of Investigation,  
22 amongst other Federal departments and agencies.

23           (6) Almost all working dogs work in tandem  
24 with our Armed Forces and law enforcement officers

1       until they are no longer medically able, at which  
2       point they are medically separated.

3               (7) The future of retired working dogs with re-  
4       spect to ownership and provision of medical services  
5       is often unclear and the medical treatment required  
6       by many former working dogs is significant enough  
7       that it creates a hardship for the individuals, often  
8       former partners, who take in these canine heroes.

9       **SEC. 3. GRANT PROGRAM TO FUND COVERED MEDICAL EX-**  
10               **PENSES FOR QUALIFIED WORKING DOGS.**

11       (a) ESTABLISHMENT.—Not later than 1 fiscal year  
12       after the date of enactment of this Act, and each fiscal  
13       year thereafter for 4 fiscal years, the Attorney General  
14       shall carry out a program under which the Attorney Gen-  
15       eral may award grants, each in amounts not to exceed  
16       \$575,000, to eligible nonprofit organizations to assist with  
17       the covered medical expenses of qualified working dogs.

18       (b) ELIGIBILITY.—A nonprofit organization is eligi-  
19       ble to receive a grant under this section if the organization  
20       primarily exists to care for qualified working dogs and  
21       provide medically related financial assistance to owners of  
22       qualified working dogs.

23       (c) APPLICATION.—To receive a grant under this sec-  
24       tion, a nonprofit organization shall submit to the Attorney  
25       General an application at such time, in such manner, and

1 containing such information as the Attorney General may  
2 require, including information that demonstrates that the  
3 nonprofit organization meets the eligibility requirements  
4 under subsection (b).

5 (d) USE OF FUNDS.—A recipient of a grant under  
6 this section shall use such grant to pay for covered medical  
7 expenses of qualified working dogs.

8 (e) GRANT AMOUNT REDUCTION.—A grant amount  
9 awarded to an eligible nonprofit organization for a fiscal  
10 year pursuant to this section shall be reduced by an  
11 amount equal to the total amount of unexpended grant  
12 funds awarded under this section in previous fiscal years.

13 (f) REPORT.—The Attorney General shall submit to  
14 Congress a report that details—

15 (1) the number of qualified working dogs as-  
16 sisted pursuant to a grant awarded under this sec-  
17 tion; and

18 (2) the average medical expenses for each quali-  
19 fied working dog assisted pursuant to a grant  
20 awarded under this section.

21 (g) DEFINITIONS.—In this Act—

22 (1) the term “covered medical expenses” means  
23 any expenses related to medical treatment and care  
24 of qualified working dogs, including veterinarian of-

1        fice visits, medical procedures, diagnostic tests, and  
2        medications or medically necessary supplements; and

3            (2) the term “qualified working dog” means a  
4        retired dog that worked for the Federal Government,  
5        including the Armed Forces, to carry out military or  
6        law enforcement activity.

7        (h) AUTHORIZATION OF APPROPRIATIONS.—There is  
8        authorized to be appropriated to carry out this Act  
9        \$5,000,000 for each of fiscal years 2021 through 2025.
