## A BILL

To require public housing agencies to inform residents of a public housing project when a resident of such project tests positive for the Coronavirus Disease 2019 (COVID-19), and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Informed Resident No-  
5 tification Act of 2020”.

1 **SEC. 2. DISCLOSURE OF COVID-19 CASES IN PUBLIC HOUS-**  
2 **ING.**

3 (a) REQUIREMENT.—Notwithstanding any other pro-  
4 vision of law, the Secretary of Housing and Urban Devel-  
5 opment shall establish such guidelines and requirements  
6 as may be necessary to require, and to establish a proce-  
7 dure for, each public housing agency that operates or ad-  
8 ministers public housing (as such term is defined in sec-  
9 tion 3(b) of the United States Housing Act of 1937 (42  
10 U.S.C. 1437a(b))) to promptly inform residents of a public  
11 housing project, upon acquisition of reliable information  
12 that any resident of the project has been determined by  
13 a qualified health agency to have tested positive for the  
14 coronavirus or the Coronavirus Disease 2019 (COVID-  
15 19), that a resident of the project has so tested positive.

16 (b) MEANS OF NOTIFICATION.—The guidelines and  
17 requirements required under subsection (a) shall specify  
18 the manner by which residents of a public housing project  
19 are provided information required under such subsection.

20 (c) REMOVAL OF PERSONALLY IDENTIFIABLE IN-  
21 FORMATION.—In making the information required under  
22 subsection (a) available to the public, the Secretary shall  
23 ensure that appropriate administrative and physical safe-  
24 guards are in place to remove all personally identifiable  
25 information.

1       (d) ISSUANCE; EFFECTIVE DATE.—The Secretary of  
2   Housing and Urban Development shall issue the guide-  
3   lines and requirements required under subsection (a) not  
4   later than the expiration of the 30-day period beginning  
5   on the date of the enactment of this Act, which guidelines  
6   and requirements shall take effect upon issuance.
