## A BILL

To direct the President, in consultation with the Secretary of the Treasury, to develop and carry out a strategy to seek reimbursement from the People's Republic of China of funds made available by the United States Government to address the Coronavirus Disease 2019 (COVID-19).

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Chinese Government  
5       COVID-19 Accountability Act”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) The United States economy has been se-  
4 verely affected by the Government of the People's  
5 Republic of China's controls on media reporting that  
6 limit coverage of the Coronavirus Disease 2019  
7 (COVID-19).

8 (2) United States Government senior officials  
9 have expressed concerns about the completeness and  
10 timeliness of information China is reporting on  
11 COVID-19 and about the overall economic impact of  
12 COVID-19 in the United States.

13 (3) China should be held financially responsible  
14 for funds made available by the United States Gov-  
15 ernment to address COVID-19.

16 **SEC. 3. EXECUTIVE STRATEGY TO SEEK REIMBURSEMENT**  
17 **FROM CHINA OF FUNDS MADE AVAILABLE BY**  
18 **THE UNITED STATES GOVERNMENT TO AD-**  
19 **DRESS COVID-19.**

20 (a) EXECUTIVE STRATEGY.—The President, in con-  
21 sultation with the Secretary of the Treasury, shall develop  
22 and carry out a strategy to seek reimbursement from the  
23 People's Republic of China of funds made available by the  
24 United States Government to address COVID-19.

25 (b) REPORT.—Not later than 1 year after the date  
26 of enactment of this Act, and annually thereafter, the

1 President shall submit to the appropriate congressional  
2 committees a report on the strategy required under sub-  
3 section (a) and its implementation.

4 (c) APPROPRIATE CONGRESSIONAL COMMITTEES DE-  
5 FINED.—In this section, the term “appropriate congres-  
6 sional committees” means—

7 (1) the Committee on Appropriations, the Com-  
8 mittee on the Budget, and the Committee on Ways  
9 and Means of the House of Representatives;

10 (2) the Committee on Appropriations, the Com-  
11 mittee on the Budget, and the Committee on Fi-  
12 nance of the Senate; and

13 (3) the Joint Economic Committee.
