## A BILL

To establish Federal Regulatory Review Commissions, and  
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 This Act may be cited as the “Coronavirus Regu-  
5 latory Repeal Act of 2020”.

6 **SEC. 2. REPEAL OR MODIFICATION OF REGULATIONS DUR-**  
7 **ING THE EMERGENCY PERIOD.**

8 Any regulation waived or modified during the emer-  
9 gency period shall be repealed or modified, as applicable,

1 the day after the expiration of the emergency period and  
2 thereafter, unless a Federal Regulatory Review Commis-  
3 sion recommends the regulation should not be repealed or  
4 modified, as applicable, and a law is enacted confirming  
5 the recommendation.

6 **SEC. 3. FEDERAL REGULATORY REVIEW COMMISSIONS.**

7 (a) ESTABLISHMENT.—There are established Com-  
8 missions to be known as the “Federal Regulatory Review  
9 Commissions”.

10 (b) MEMBERS.—Each Commission shall be composed  
11 of members of the congressional committee of each jurisdic-  
12 tion and the head of each agency under the jurisdiction  
13 of that committee (in this Act referred to as the “mem-  
14 bers”).

15 (c) INFORMATION.—Members may obtain informa-  
16 tion from individuals with expertise in the operations and  
17 regulations of government programs.

18 (d) DUTIES OF THE COMMISSIONS.—

19 (1) REVIEW OF FEDERAL REGULATIONS.—Not  
20 later than 2 months after the date of the enactment  
21 of this Act, each Commission shall submit to the  
22 Speaker of the House of Representatives and the  
23 majority leader of the Senate an official rec-  
24 ommendation, on the repeal or modification of each  
25 regulation waived or modified during the emergency

1 period. Each regulation waived or modified during  
2 the emergency period shall remain waived or modi-  
3 fied, as applicable, during the review period by the  
4 Commission.

5 (2) EXTENSION.—The deadline in paragraph  
6 (1) may be extended for an additional month if the  
7 Congress enacts legislation extending such deadline  
8 by a vote of a majority of the House of Representa-  
9 tives and the Senate.

10 (e) REPORT TO CONGRESS.—

11 (1) AGENCY REPORT ON REGULATIONS.—Not  
12 later than 1 month after the date of the enactment  
13 of this Act, the head of each agency shall submit to  
14 each congressional committee of jurisdiction a report  
15 that includes—

16 (A) an analysis of whether or not the agen-  
17 cy can function without the regulation or with  
18 the modified regulation, as applicable; and

19 (B) an analysis of whether the regulation  
20 should be restored to its original state before  
21 the emergency period or should remain repealed  
22 or modified, as applicable.

23 (2) PUBLIC COMMENT PERIOD REQUIRED.—The  
24 head of an agency shall provide a public comment

1 period before submitting a report pursuant to para-  
2 graph (1).

3 (f) CONGRESSIONAL RECOMMENDATION.—Not later  
4 than 1 month after receiving a report from the head of  
5 each agency pursuant to subsection (e), each committee  
6 shall submit to the Speaker of the House of Representa-  
7 tives and the majority leader of the Senate an official rec-  
8 ommendation on whether or not the repealed or modified  
9 regulation should be re-established.

10 (g) SUNSET OF COMMISSIONS.—The Commissions  
11 established in this section shall terminate on the final day  
12 of the final recommendation by each committee.

13 **SEC. 4. DEFINITIONS.**

14 In this Act:

15 (1) AGENCY.—The term “agency” has the  
16 meaning given that term in section 551 of title 5,  
17 United States Code.

18 (2) EMERGENCY PERIOD.—The term “emer-  
19 gency period” means the duration of a public health  
20 emergency declared pursuant to section 319 of the  
21 Public Health Service Act (42 U.S.C. 247d) as a re-  
22 sult of confirmed cases of 2019 novel coronavirus  
23 (COVID–19), including any renewal thereof.

1           (3) REGULATION.—The term “regulation” has  
2           the meaning given the term “rule” under section  
3           551 of title 5, United States Code.
