Mr. BUDD (for himself, Mr. BIGGS, Mr. BERGMAN, Mr. ROUZER, Mr. CURTIS, Mr. POSEY, Mr. BISHOP of North Carolina, and Mr. MOONEY of West Virginia) introduced the following bill; which was referred to the Committee on House Administration

## A BILL

To withhold the pay of Members of the House of Representatives who cast a vote or record their presence in the House by proxy, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Pay for Proxy Vot-  
5 ing Act”.

6 **SEC. 2. WITHHOLDING PAY OF MEMBERS WHO VOTE BY**  
7 **PROXY.**

8 (a) WITHHOLDING.—If on any day during a Congress  
9 a Member of the House of Representatives uses a des-

1 designated proxy to cast a vote in the House or record the  
2 Member's presence in the House in response to a quorum  
3 call, the Chief Administrative Officer of the House of Rep-  
4 resentatives shall—

5           (1) withhold from the payments otherwise re-  
6           quired to be made with respect to a pay period for  
7           the compensation of the Member an amount equal to  
8           the product of—

9                   (A) an amount equal to one day's worth of  
10                  pay under the annual rate of pay applicable to  
11                  the Member under section 601(a) of the Legis-  
12                  lative Reorganization Act of 1946 (2 U.S.C.  
13                  4501); and

14                  (B) the number of days during the pay pe-  
15                  riod on which the Member uses a designated  
16                  proxy to cast a vote in the House or record the  
17                  Member's presence in the House in response to  
18                  a quorum call; and

19           (2) deposit in an escrow account all amounts  
20           withheld under paragraph (1).

21           (b) RELEASE OF AMOUNTS AT END OF THE CON-  
22           GRESS.—In order to ensure that this section is carried out  
23           in a manner that shall not vary the compensation of Rep-  
24           resentatives in violation of the twenty-seventh article of  
25           amendment to the Constitution of the United States, the

1 Chief Administrative Officer shall release for payments to  
2 Members any amounts remaining in any escrow account  
3 under this section on the last day of the Congress during  
4 which the amounts were deposited in the account.

5 (c) ROLE OF SECRETARY OF THE TREASURY.—The  
6 Secretary of the Treasury shall provide the Chief Adminis-  
7 trative Officer with such assistance as may be necessary  
8 to enable the Chief Administrative Officer to carry out this  
9 section.
