A BILL

To expand the boundary of Saguaro National Park, to study additional land for future adjustments to the boundary of the park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Saguaro National Park*
 5 *Boundary Expansion and Study Act of 2020”.*

6 **SEC. 2. BOUNDARY OF SAGUARO NATIONAL PARK.**

7 *Section 4 of the Saguaro National Park Establishment*
 8 *Act of 1994 (Public Law 103–364; 108 Stat. 3467) is*
 9 *amended—*

10 *(1) in subsection (a)—*

11 *(A) by inserting “(1)” before “The bound-*
 12 *aries of the park”; and*

13 *(B) by adding at the end the following:*

14 *“(2)(A) The boundaries of the park are further*
 15 *modified to include approximately 1,232 acres, as*
 16 *generally depicted on the map titled ‘Saguaro Na-*
 17 *tional Park__ Proposed Boundary Adjustment’, num-*
 18 *bered 151/80,045G, and dated June 2020.*

19 *“(B) The map referred to in subparagraph (A)*
 20 *shall be on file and available for inspection in the ap-*
 21 *propriate offices of the National Park Service.”;*

22 *(2) by striking subsection (b)(2) and inserting*
 23 *the following new paragraphs:*

24 *“(2) The Secretary may, with the consent of the*
 25 *State of Arizona and in accordance with Federal and*

1 *State law, acquire land or interests therein owned by*
 2 *the State of Arizona within the boundary of the park.*

3 *“(3) If the Secretary is unable to acquire the*
 4 *State land under paragraph (2), the Secretary may*
 5 *enter into an agreement with the State that would*
 6 *allow the National Park Service to manage State*
 7 *land within the boundary of the park.”; and*

8 *(3) by adding at the end the following new sub-*
 9 *section:*

10 *“(d) BOUNDARY STUDY.—*

11 *“(1) IN GENERAL.—The Secretary shall conduct*
 12 *a study to identify any lands outside the boundaries*
 13 *of the park that may be appropriate for inclusion in*
 14 *the park.*

15 *“(2) CRITERIA.—The study be conducted in ac-*
 16 *cordance with National Park Service criteria for*
 17 *boundary adjustment studies.*

18 *“(3) REPORT.—Not later than 3 years after the*
 19 *date funds are made available for the study under*
 20 *this subsection, the Secretary shall submit to the Com-*
 21 *mittee on Natural Resources of the House of Rep-*
 22 *resentatives and the Committee on Energy and Nat-*
 23 *ural Resources of the Senate a report on the findings,*
 24 *conclusions, and recommendations of the study.”.*

Amend the title so as to read: “A bill to expand the boundary of Saguaro National Park, to authorize a study

of additional land for potential inclusion in the park, and for other purposes.”.
