## A BILL

To permit the Administrator of the Small Business Administration to deem certain nonprofit organizations serving developmentally disabled individuals as eligible to participate in the paycheck protection program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PAYCHECK PROTECTION PROGRAM ELIGI-**  
2 **BILITY FOR CERTAIN NONPROFIT ORGANIZA-**  
3 **TIONS SERVING DEVELOPMENTALLY DIS-**  
4 **ABLED INDIVIDUALS.**

5 Section 7(a)(36)(D) of the Small Business Act (15  
6 U.S.C. 636(a)(36)(D)) is amended by adding at the end  
7 the following new clause:

8 “(vii) NONPROFITS SERVING CERTAIN  
9 DISABLED INDIVIDUALS.—

10 “(I) SIZE STANDARD WAIVER.—

11 For the purposes of determining  
12 whether a covered nonprofit organiza-  
13 tion is eligible to receive a covered  
14 loan, the Administrator may deem  
15 such organization as employing not  
16 more than the size standard in num-  
17 ber of employees established by the  
18 Administration for the industry in  
19 which such organization operates or,  
20 if no such size standard is applicable,  
21 not more than 500 employees.

22 “(II) REVENUE NOT BASIS FOR  
23 INELIGIBILITY.—A covered nonprofit  
24 organization may not be determined  
25 to be ineligible for a covered loan due

1 to the annual gross receipts of such  
2 organization.

3 “(III) COVERED NONPROFIT OR-  
4 GANIZATION DEFINED.—In this  
5 clause, the term ‘covered nonprofit or-  
6 ganization’ means a nonprofit organi-  
7 zation that—

8 “(aa) that provides home  
9 and community-based services (as  
10 referred to in section 1915(e)(1)  
11 of the Social Security Act (42  
12 U.S.C. 1396n(c)(1))) to individ-  
13 uals with developmental disabil-  
14 ities (as defined in section 102(8)  
15 of the Developmental Disabilities  
16 Assistance and Bill of Rights Act  
17 of 2000 (42 U.S.C. 15002(8)));  
18 and

19 “(bb) whose annual gross  
20 receipts do not exceed  
21 \$30,000,000.”.
