A BILL

To prohibit the use of Federal funds to implement, administer, or enforce the Presidential Memorandum on Excluding Illegal Aliens From the Apportionment Base Following the 2020 Census, issued on July 21, 2020.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “No Funds for Appor-
3 tionment Exclusion Act”.

4 **SEC. 2. PROHIBITION ON USE OF FEDERAL FUNDS.**

5 No Federal funds, resources, or fees made available
6 to any Federal agency may be used to implement, admin-
7 ister, enforce, or carry out (including through the issuance
8 of any regulations) any of the policy changes set forth in
9 the Presidential Memorandum on Excluding Illegal Aliens
10 From the Apportionment Base Following the 2020 Cen-
11 sus, issued on July 21, 2020.
