## A BILL

To amend the Wild and Scenic Rivers Act to designate segments of the Nashua, Squannacook, and Nissitissit Rivers as components of the Wild and Scenic Rivers System, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Nashua River Wild  
5       and Scenic River Act of 2019”.

1 **SEC. 2. NASHUA WILD AND SCENIC RIVERS, MASSACHU-**  
2 **SETTS AND NEW HAMPSHIRE.**

3 (a) DESIGNATION OF WILD AND SCENIC RIVER SEG-  
4 MENTS.—Section 3(a) of the Wild and Scenic Rivers Act  
5 (16 U.S.C. 1274(a)) is amended by adding at the end the  
6 following:

7 “(214) NASHUA, SQUANNACOOK, AND  
8 NISSITISSIT WILD AND SCENIC RIVERS, MASSACHU-  
9 SETTS AND NEW HAMPSHIRE.—

10 “(A) The following segments in the Com-  
11 monwealth of Massachusetts and State of New  
12 Hampshire, to be administered by the Secretary  
13 of the Interior as a scenic river:

14 “(i) The approximately 27-mile seg-  
15 ment of the mainstem of the Nashua River  
16 from the confluence of the North and  
17 South Nashua Rivers in Lancaster, Massa-  
18 chusetts, and extending north to the Mas-  
19 sachusetts-New Hampshire border, except  
20 as provided in subparagraph (B).

21 “(ii) The approximately 16.3-mile seg-  
22 ment of the Squannacook River from its  
23 headwaters in Ash Swamp, Townsend,  
24 Massachusetts, extending downstream to  
25 the confluence of the river with the Nash-

1           ua River in Shirley/Ayer, Massachusetts,  
2           except as provided in subparagraph (B).

3           “(iii) The approximately 9.5-mile seg-  
4           ment of the Nissitissit River from its head-  
5           waters in Brookline, New Hampshire, to  
6           the confluence of the river with the Nash-  
7           ua River in Pepperell, Massachusetts.

8           “(B) EXCLUSION AREAS.—The designation  
9           of the river segments in subparagraph (A) shall  
10          exclude—

11          “(i) with respect to the Ice House hy-  
12          droelectric project (FERC P–12769), from  
13          700 feet upstream from the crest of the  
14          dam to 500 feet downstream from the  
15          crest of the dam;

16          “(ii) with respect to the Pepperell hy-  
17          droelectric project (FERC P12721), from  
18          9,240 feet upstream from the crest of the  
19          dam to 1,000 feet downstream from the  
20          crest of the dam; and

21          “(iii) with respect to the Hollings-  
22          worth and Vose dam (non-FERC), from  
23          1,200 feet upstream from the crest of the  
24          dam to 2,665 feet downstream from the  
25          crest of the dam.”.

1 (b) MANAGEMENT.—

2 (1) PROCESS.—

3 (A) IN GENERAL.—The river segments  
4 designated by paragraph (214) of section 3(a)  
5 of such Act (16 U.S.C. 1274(a)), as amended  
6 by this section, shall be managed in accordance  
7 with—

8 (i) the Nashua, Squannacook, and  
9 Nissitissit Rivers Stewardship Plan devel-  
10 oped pursuant to the study described in  
11 section 5(b)(21) of such Act (16 U.S.C.  
12 1276(b)(21)) (referred to in this sub-  
13 section as the “management plan”), dated  
14 February 15, 2018; and

15 (ii) such amendments to the manage-  
16 ment plan as the Secretary of the Interior  
17 determines are consistent with this section  
18 and as are approved by the Nashua,  
19 Squannacook, and Nissitissit Rivers Stew-  
20 ardship Council (referred to in this sub-  
21 section as the “Stewardship Council”).

22 (B) COMPREHENSIVE MANAGEMENT  
23 PLAN.—The management plan shall be consid-  
24 ered to satisfy the requirements for a com-

1           prehensive management plan under section 3(d)  
2           of such Act (16 U.S.C. 1274(d)).

3           (2) COMMITTEE.—The Secretary of the Interior  
4           shall coordinate the management responsibilities of  
5           the Secretary of the Interior under this Act with the  
6           Stewardship Council, as specified in the manage-  
7           ment plan.

8           (3) COOPERATIVE AGREEMENTS.—

9           (A) IN GENERAL.—In order to provide for  
10          the long-term protection, preservation, and en-  
11          hancement of the river segments designated by  
12          paragraph (214) of section 3(a) of such Act (16  
13          U.S.C. 1274(a)), as amended by this section,  
14          the Secretary of the Interior may enter into co-  
15          operative agreements pursuant to sections 10(e)  
16          and 11(b)(1) (16 U.S.C. 1281(e), 1282(b)(1))  
17          of such Act with—

18                 (i) the Commonwealth of Massachu-  
19                 setts and the State of New Hampshire;

20                 (ii) the municipalities of—

21                         (I) Ayer, Bolton, Dunstable,  
22                         Groton, Harvard, Lancaster, Pepper-  
23                         ell, Shirley, and Townsend in Massa-  
24                         chusetts; and

1 (II) Brookline and Hollis in New  
2 Hampshire; and

3 (iii) appropriate local, regional, State,  
4 or multistate, planning, environmental, or  
5 recreational organizations.

6 (B) CONSISTENCY.—Each cooperative  
7 agreement entered into under this paragraph  
8 shall be consistent with the management plan  
9 and may include provisions for financial or  
10 other assistance from the United States.

11 (4) EFFECT ON WORKING DAMS.—

12 (A) IN GENERAL.—The designation of the  
13 river segments by paragraph (214) of section  
14 3(a) of such Act (16 U.S.C. 1274(a)), as  
15 amended by this section, does not—

16 (i) impact or alter the existing terms  
17 of permitting, licensing, or operation of—

18 (I) the Pepperell hydroelectric  
19 project (FERC Project P-12721,  
20 Nashua River, Pepperell, MA);

21 (II) the Ice House hydroelectric  
22 project (FERC Project P-12769,  
23 Nashua River, Ayer, MA); or

24 (III) the Hollingsworth and Vose  
25 Dam (non-FERC industrial facility,

1 Squannacook River, West Groton,  
2 MA) as further described in the man-  
3 agement plan (Appendix A, “Working  
4 Dams”); or

5 (ii) preclude the Federal Energy Reg-  
6 ulatory Commission from licensing, reli-  
7 censing, or otherwise authorizing the oper-  
8 ation or continued operation of the  
9 Pepperell and Ice House hydroelectric  
10 projects under the terms of licenses or ex-  
11 emptions in effect on the date of enact-  
12 ment of this Act; or

13 (iii) limit actions taken to modernize,  
14 upgrade, or carry out other changes to  
15 such projects authorized pursuant to  
16 clause (i), subject to written determination  
17 by the Secretary of the Interior that the  
18 changes are consistent with the purposes  
19 of the designation.

20 (5) LAND MANAGEMENT.—

21 (A) ZONING ORDINANCES.—For the pur-  
22 pose of the segments designated by paragraph  
23 (214) of section 3(a) of such Act (16 U.S.C.  
24 1274(a)), as amended by this section, the zon-  
25 ing ordinances adopted by the municipalities

1 named in paragraph (3)(A)(ii), including provi-  
2 sions for conservation of floodplains, wetlands,  
3 and watercourses associated with the segments,  
4 shall be deemed to satisfy the standards and re-  
5 quirements of section 6(c) of such Act (16  
6 U.S.C. 1277(c)).

7 (B) ACQUISITIONS OF LANDS.—The au-  
8 thority of the Secretary to acquire land for the  
9 purposes of the segments designated such para-  
10 graph (214) shall be—

11 (i) limited to acquisition by donation  
12 or acquisition with the consent of the  
13 owner of the land; and

14 (ii) subject to the additional criteria  
15 set forth in the management plan.

16 (C) NO CONDEMNATION.—No land or in-  
17 terest in land within the boundary of the river  
18 segments designated by such paragraph (214)  
19 may be acquired by condemnation.

20 (6) RELATION TO THE NATIONAL PARK SYS-  
21 TEM.—Notwithstanding section 10(c) of such Act  
22 (16 U.S.C. 1281(c)), each segment of the Nashua,  
23 Squannacook, and Nissitissit Rivers designated as a  
24 component of the Wild and Scenic Rivers System  
25 under this Act shall not—



1                   (A) be administered as a unit of the Na-  
2                   tional Park System; or

3                   (B) be subject to regulations that govern  
4                   the National Park System.
