14 sider in the House the resolution (H. Res. 1154) con-
15 demning QAnon and rejecting the conspiracy theories it
16 promotes. The resolution shall be considered as read. The
17 previous question shall be considered as ordered on the
18 resolution and preamble to adoption without intervening
19 motion or demand for division of the question except one
20 hour of debate equally divided and controlled by the chair
21 and ranking minority member of the Committee on the
22 Judiciary.
