## RESOLUTION

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House any bill specified  
3 in section 2 of this resolution. All points of order against  
4 consideration of each such bill are waived. Each such bill  
5 shall be considered as read. All points of order against  
6 provisions in each such bill are waived. The previous ques-  
7 tion shall be considered as ordered on each such bill and  
8 on any amendment thereto to final passage without inter-  
9 vening motion except: (1) one hour of debate equally di-  
10 vided and controlled by the chair and ranking minority  
11 member of the Committee on Appropriations or their re-  
12 spective designees; and (2) one motion to recommit.

13       SEC. 2. The bills referred to in the first section of  
14 this resolution are as follows:

1       (a) The bill (H.R. 264) making appropriations for fi-  
2 nancial services and general government for the fiscal year  
3 ending September 30, 2019, and for other purposes.

4       (b) The bill (H.R. 265) making appropriations for  
5 Agriculture, Rural Development, Food and Drug Adminis-  
6 tration, and Related Agencies programs for the fiscal year  
7 ending September 30, 2019, and for other purposes.

8       (c) The bill (H.R. 266) making appropriations for the  
9 Department of the Interior, environment, and related  
10 agencies for the fiscal year ending September 30, 2019,  
11 and for other purposes.

12       (d) The bill (H.R. 267) making appropriations for the  
13 Department of Transportation, and Housing and Urban  
14 Development, and related agencies for the fiscal year end-  
15 ing September 30, 2019, and for other purposes.

16       SEC. 3. The requirement of clause 6(a) of rule XIII  
17 for a two-thirds vote to consider a report from the Com-  
18 mittee on Rules on the same day it is presented to the  
19 House is waived with respect to any resolution reported  
20 through the legislative day of January 15, 2019, relating  
21 to a measure making or continuing appropriations for the  
22 fiscal year ending September 30, 2019
