# RESOLUTION

Impeaching Donald John Trump, President of the United  
States, of high misdemeanors.

- 1        *Resolved*, that Donald John Trump, President of the
- 2   United States, is unfit to be President, unfit to represent
- 3   the American values of decency and morality, respect-
- 4   ability and civility, honesty and propriety, reputability and
- 5   integrity, is unfit to defend the ideals that have made
- 6   America great, unfit to defend liberty and justice for all
- 7   as extolled in the Pledge of Allegiance, is unfit to defend
- 8   the American ideal of all persons being created equal as
- 9   exalted in the Declaration of Independence, is unfit to en-
- 10   sure domestic tranquility, promote the general welfare and

1 to ensure the blessings of liberty to ourselves and our pos-  
2 terity as lauded in the preamble to the United States Con-  
3 stitution, is unfit to protect the government of the people,  
4 by the people, for the people as elucidated in the Gettys-  
5 burg Address, and is impeached for high misdemeanors  
6 that the following Article of Impeachment be exhibited to  
7 the Senate: Article of Impeachment exhibited by the  
8 House of Representatives of the United States, in the  
9 name of itself, of the people of the United States, against  
10 Donald John Trump, President of the United States, in  
11 maintenance and support of its impeachment against him  
12 for high misdemeanors committed as President consti-  
13 tuting harm to American society to the manifest injury  
14 of the people of the United States:

15    ARTICLE I

16         The House of Representatives on July 16, 2019,  
17 strongly condemned President Donald Trump's racist  
18 comments that have legitimized and increased fear and ha-  
19 tred of new Americans and people of color by saying that  
20 our fellow Americans who are immigrants, and those who  
21 may look to the President like immigrants, should "go  
22 back" to other countries, by referring to immigrants and  
23 asylum seekers as "invaders" and by saying that Members  
24 of Congress who are immigrants, or those of our col-  
25 leagues who are wrongly assumed to be immigrants, do  
26 not belong in Congress or the United States of America.

1        In all of this, the aforementioned Donald John  
2 Trump has, by his statements, brought the high office of  
3 the President of the United States in contempt, ridicule,  
4 disgrace, and disrepute, has sown seeds of discord among  
5 the people of the United States, has demonstrated that  
6 he is unfit to be President, and has betrayed his trust as  
7 President of the United States to the manifest injury of  
8 the people of the United States, and has committed a high  
9 misdemeanor in office.

10      Therefore, Donald John Trump by causing such  
11 harm to the society of the United States is unfit to be  
12 President and warrants impeachment, trial, and removal  
13 from office.
