Ms. SCANLON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2203) to increase transparency, accountability, and community engagement within the Department of Homeland Security, provide independent oversight of border security activities, improve training for agents and officers of U.S.

Customs and Border Protection and U.S. Immigration and Customs Enforcement, and for other purposes; providing for consideration of the bill (H.R. 3525) to amend the Homeland Security Act of 2002 to direct the Commissioner of U.S. Customs and Border Protection to establish uniform processes for medical screening of individuals interdicted between ports of entry, and for other purposes; providing for consideration of the resolution (H. Res. 576) expressing the sense of the House of Representatives with respect to the whistleblower complaint of August 12, 2019, made to the Inspector General of the Intelligence Community; and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 2203) to increase transparency, accountability, and com-  
4 munity engagement within the Department of Homeland  
5 Security, provide independent oversight of border security  
6 activities, improve training for agents and officers of U.S.  
7 Customs and Border Protection and U.S. Immigration  
8 and Customs Enforcement, and for other purposes. All  
9 points of order against consideration of the bill are waived.  
10 In lieu of the amendment in the nature of a substitute  
11 recommended by the Committee on Homeland Security  
12 now printed in the bill, an amendment in the nature of  
13 a substitute consisting of the text of Rules Committee  
14 Print 116-27, modified by the amendment printed in the  
15 report of the Committee on Rules accompanying this reso-

1 lution, shall be considered as adopted. The bill, as amend-  
2 ed, shall be considered as read. All points of order against  
3 provisions in the bill, as amended, are waived. The pre-  
4 vious question shall be considered as ordered on the bill,  
5 as amended, and on any further amendment thereto, to  
6 final passage without intervening motion except: (1) one  
7 hour of debate equally divided and controlled by the chair  
8 and ranking minority member of the Committee on Home-  
9 land Security; and (2) one motion to recommit with or  
10 without instructions.

11       SEC. 2. Upon adoption of this resolution it shall be  
12 in order to consider in the House the bill (H.R. 3525)  
13 to amend the Homeland Security Act of 2002 to direct  
14 the Commissioner of U.S. Customs and Border Protection  
15 to establish uniform processes for medical screening of in-  
16 dividuals interdicted between ports of entry, and for other  
17 purposes. All points of order against consideration of the  
18 bill are waived. In lieu of the amendment in the nature  
19 of a substitute recommended by the Committee on Home-  
20 land Security now printed in the bill, an amendment in  
21 the nature of a substitute consisting of the text of Rules  
22 Committee Print 116-33 shall be considered as adopted.  
23 The bill, as amended, shall be considered as read. All  
24 points of order against provisions in the bill, as amended,  
25 are waived. The previous question shall be considered as

1 ordered on the bill, as amended, and on any further  
2 amendment thereto, to final passage without intervening  
3 motion except: (1) one hour of debate equally divided and  
4 controlled by the chair and ranking minority member of  
5 the Committee on Homeland Security; and (2) one motion  
6 to recommit with or without instructions.

7       SEC. 3. Upon adoption of this resolution it shall be  
8 in order without intervention of any point of order to con-  
9 sider in the House the resolution (H. Res. 576) expressing  
10 the sense of the House of Representatives with respect to  
11 the whistleblower complaint of August 12, 2019, made to  
12 the Inspector General of the Intelligence Community. The  
13 resolution shall be considered as read. The previous ques-  
14 tion shall be considered as ordered on the resolution and  
15 preamble to adoption without intervening motion or de-  
16 mand for division of the question except one hour of de-  
17 bate equally divided and controlled by the chair and rank-  
18 ing minority member of the Permanent Select Committee  
19 on Intelligence.

20       SEC. 4. It shall be in order at any time on the legisla-  
21 tive day of September 26, 2019, for the Speaker to enter-  
22 tain motions that the House suspend the rules as though  
23 under clause 1 of rule XV. The Speaker or her designee  
24 shall consult with the Minority Leader or his designee on

1 the designation of any matter for consideration pursuant  
2 to this section.

3 SEC. 5. On any legislative day during the period from  
4 September 30, 2019, through October 14, 2019—

5 (a) the Journal of the proceedings of the previous day  
6 shall be considered as approved; and

7 (b) the Chair may at any time declare the House ad-  
8 journed to meet at a date and time, within the limits of  
9 clause 4, section 5, article I of the Constitution, to be an-  
10 nounced by the Chair in declaring the adjournment.

11 SEC. 6. The Speaker may appoint Members to per-  
12 form the duties of the Chair for the duration of the period  
13 addressed by section 5 of this resolution as though under  
14 clause 8 (a) of rule I.

15 SEC. 7. Each day during the period addressed by sec-  
16 tion 5 of this resolution shall not constitute a calendar  
17 day for purposes of section 7 of the War Powers Resolu-  
18 tion (50 U.S.C. 1546).

19 SEC. 8. Each day during the period addressed by sec-  
20 tion 5 of this resolution shall not constitute a legislative  
21 day for purposes of clause 7 of rule XIII.

22 SEC. 9. Each day during the period addressed by sec-  
23 tion 5 of this resolution shall not constitute a calendar  
24 or legislative day for purposes of clause 7(c)(1) of rule

25 XXII. Sec. 10. Each day during the period addressed by

- 1 section 5 of this resolution shall not constitute a legislative
- 2 day for purposes of clause 7 of rule XV.
