Mr. MORELLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 648) making appropriations for the fiscal year ending September 30, 2019, and for other purposes; providing for consideration of the joint resolution (H.J. Res. 31) making further continuing appropriations for the Department of Homeland Security for fiscal year 2019, and for other purposes; providing for consideration of motions to suspend the rules; and waiving a requirement of clause 6(a) of

rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 648) making appropriations for the fiscal year ending Sep-
4 tember 30, 2019, and for other purposes. All points of
5 order against consideration of the bill are waived. The bill
6 shall be considered as read. All points of order against
7 provisions in the bill are waived. Clause 2(e) of rule XXI
8 shall not apply during consideration of the bill. The pre-
9 vious question shall be considered as ordered on the bill
10 and on any amendment thereto to final passage without
11 intervening motion except: (1) one hour of debate equally
12 divided and controlled by the chair and ranking minority
13 member of the Committee on Appropriations or their re-
14 spective designees; and (2) one motion to recommit.

15 SEC. 2. Upon adoption of this resolution it shall be
16 in order to consider in the House the joint resolution (H.J.
17 Res. 31) making further continuing appropriations for the
18 Department of Homeland Security for fiscal year 2019,
19 and for other purposes. All points of order against consid-
20 eration of the joint resolution are waived. The joint resolu-
21 tion shall be considered as read. All points of order against
22 provisions in the joint resolution are waived. The previous
23 question shall be considered as ordered on the joint resolu-
24 tion and on any amendment thereto to final passage with-

1 out intervening motion except: (1) one hour of debate
2 equally divided and controlled by the chair and ranking
3 minority member of the Committee on Appropriations or
4 their respective designees; and (2) one motion to recom-
5 mit.

6 SEC. 3. It shall be in order at any time through the
7 legislative day of February 1, 2019, for the Speaker to
8 entertain motions that the House suspend the rules as
9 though under clause 1 of rule XV. The Speaker or her
10 designee shall consult with the Minority Leader or his des-
11 ignee on the designation of any matter for consideration
12 pursuant to this section.

13 SEC. 4. The requirement of clause 6(a) of rule XIII
14 for a two-thirds vote to consider a report from the Com-
15 mittee on Rules on the same day it is presented to the
16 House is waived with respect to any resolution reported
17 through the legislative day of January 30, 2019, relating
18 to a measure making or continuing appropriations for the
19 fiscal year ending September 30, 2019.
