Mr. DESAULNIER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1309) to direct the Secretary of Labor to issue an occupational safety and health standard that requires covered employers within the health care and social service industries to develop and implement a comprehensive workplace violence prevention plan, and for other purposes; providing for proceedings during the period from November 22, 2019, through December 2, 2019; and providing for consideration of motions to suspend the rules.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1309) to direct the Secretary of
6 Labor to issue an occupational safety and health standard
7 that requires covered employers within the health care and
8 social service industries to develop and implement a com-
9 prehensive workplace violence prevention plan, and for
10 other purposes. The first reading of the bill shall be dis-
11 pensed with. All points of order against consideration of
12 the bill are waived. General debate shall be confined to
13 the bill and shall not exceed one hour equally divided and
14 controlled by the chair and ranking minority member of
15 the Committee on Education and Labor. After general de-
16 bate the bill shall be considered for amendment under the
17 five-minute rule. In lieu of the amendment in the nature
18 of a substitute recommended by the Committee on Edu-
19 cation and Labor now printed in the bill, an amendment
20 in the nature of a substitute consisting of the text of Rules
21 Committee Print 116-37, modified by the amendment
22 printed in part A of the report of the Committee on Rules
23 accompanying this resolution, shall be considered as
24 adopted in the House and in the Committee of the Whole.
25 The bill, as amended, shall be considered as the original

1 bill for the purpose of further amendment under the five-
2 minute rule and shall be considered as read. All points
3 of order against provisions in the bill, as amended, are
4 waived. No further amendment to the bill, as amended,
5 shall be in order except those printed in part B of the
6 report of the Committee on Rules. Each such further
7 amendment may be offered only in the order printed in
8 the report, may be offered only by a Member designated
9 in the report, shall be considered as read, shall be debat-
10 able for the time specified in the report equally divided
11 and controlled by the proponent and an opponent, shall
12 not be subject to amendment, and shall not be subject to
13 a demand for division of the question in the House or in
14 the Committee of the Whole. All points of order against
15 such further amendments are waived. At the conclusion
16 of consideration of the bill for amendment the Committee
17 shall rise and report the bill, as amended, to the House
18 with such further amendments as may have been adopted.
19 The previous question shall be considered as ordered on
20 the bill, as amended, and on any further amendment
21 thereto to final passage without intervening motion except
22 one motion to recommit with or without instructions.

23 SEC. 2. On any legislative day during the period from
24 November 22, 2019, through December 2, 2019—

1 (a) the Journal of the proceedings of the previous day
2 shall be considered as approved; and

3 (b) the Chair may at any time declare the House ad-
4 journed to meet at a date and time, within the limits of
5 clause 4, section 5, article I of the Constitution, to be an-
6 nounced by the Chair in declaring the adjournment.

7 SEC. 3. The Speaker may appoint Members to per-
8 form the duties of the Chair for the duration of the period
9 addressed by section 2 of this resolution as though under
10 clause 8(a) of rule I.

11 SEC. 4. Each day during the period addressed by sec-
12 tion 2 of this resolution shall not constitute a calendar
13 or legislative day for purposes of clause 7(c)(1) of rule
14 XXII.

15 SEC. 5. It shall be in order at any time on the legisla-
16 tive day of November 21, 2019, for the Speaker to enter-
17 tain motions that the House suspend the rules as though
18 under clause 1 of rule XV. The Speaker or her designee
19 shall consult with the Minority Leader or his designee on
20 the designation of any matter for consideration pursuant
21 to this section.
