Providing for consideration of the bill (H.R. 2534) to amend the Securities Exchange Act of 1934 to prohibit certain securities trading and related communications by those who possess material, nonpublic information, and relating to consideration of the concurrent resolution (H. Res. 77) directing the President pursuant to section 5(c) of the War Powers Resolution to remove United States Armed Forces from hostilities in the Syrian Arab Republic that have not been authorized by Congress.

Mr. PERLMUTTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2534) to amend the Securities Exchange Act of 1934 to prohibit certain securities trading and related communications by those who possess material, nonpublic information, and relating to consideration of the concurrent resolution (H. Con. Res. 77) directing the President pursuant to section 5(c) of the War Powers Resolution to remove United States Armed Forces from hostilities in the Syrian Arab Republic that have not been authorized by Congress.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2534) to amend the Securities Ex-
6 change Act of 1934 to prohibit certain securities trading
7 and related communications by those who possess mate-
8 rial, nonpublic information. The first reading of the bill
9 shall be dispensed with. All points of order against consid-
10 eration of the bill are waived. General debate shall be con-
11 fined to the bill and shall not exceed one hour equally di-
12 vided and controlled by the chair and ranking minority
13 member of the Committee on Financial Services. After
14 general debate the bill shall be considered for amendment
15 under the five-minute rule. In lieu of the amendment in
16 the nature of a substitute recommended by the Committee
17 on Financial Services now printed in the bill, an amend-
18 ment in the nature of a substitute consisting of the text
19 of Rules Committee Print 116-39 shall be considered as
20 adopted in the House and in the Committee of the Whole.
21 The bill, as amended, shall be considered as the original
22 bill for the purpose of further amendment under the five-
23 minute rule and shall be considered as read. All points
24 of order against provisions in the bill, as amended, are
25 waived. No further amendment to the bill, as amended,

1 shall be in order except those printed in the report of the
2 Committee on Rules accompanying this resolution. Each
3 such further amendment may be offered only in the order
4 printed in the report, may be offered only by a Member
5 designated in the report, shall be considered as read, shall
6 be debatable for the time specified in the report equally
7 divided and controlled by the proponent and an opponent,
8 shall not be subject to amendment, and shall not be sub-
9 ject to a demand for division of the question in the House
10 or in the Committee of the Whole. All points of order
11 against such further amendments are waived. At the con-
12 clusion of consideration of the bill for amendment the
13 Committee shall rise and report the bill, as amended, to
14 the House with such further amendments as may have
15 been adopted. The previous question shall be considered
16 as ordered on the bill, as amended, and on any further
17 amendment thereto to final passage without intervening
18 motion except one motion to recommit with or without in-
19 structions.

20 SEC. 2. (a) At any time on the legislative day of
21 Wednesday, December 11, 2019, it shall be in order with-
22 out intervention of any point of order to consider in the
23 House a motion to discharge the Committee on Foreign
24 Affairs from further consideration of the concurrent reso-
25 lution (H. Con. Res. 77) directing the President pursuant

1 to section 5(c) of the War Powers Resolution to remove
2 United States Armed Forces from hostilities in the Syrian
3 Arab Republic that have not been authorized by Congress,
4 if offered by Representative Gabbard of Hawaii. The mo-
5 tion shall be considered as read. The previous question
6 shall be considered as ordered on the motion to its adop-
7 tion without intervening motion except 20 minutes of de-
8 bate equally divided and controlled by Representative
9 Gabbard of Hawaii and an opponent. The question of
10 adoption of the motion may be subject to postponement
11 as though under clause 8 of rule XX.

12 (b) The provisions of section 7 of the War Powers
13 Resolution (50 U.S.C. 1546) shall not apply during the
14 remainder of the One Hundred Sixteenth Congress to
15 House Concurrent Resolution 77.
