Mr. RASKIN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4) to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, and providing for consideration of the resolution (H. Res. 326) expressing the sense of the House of Representatives regarding United States efforts to resolve the Israeli-Palestinian conflict through a negotiated two-state solution.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 4) to amend the Voting Rights Act of 1965 to revise the
4 criteria for determining which States and political subdivi-
5 sions are subject to section 4 of the Act, and for other
6 purposes. All points of order against consideration of the
7 bill are waived. The amendment in the nature of a sub-
8 stitute recommended by the Committee on the Judiciary
9 now printed in the bill, modified by the amendment print-
10 ed in part A of the report of the Committee on Rules ac-
11 companying this resolution, shall be considered as adopt-
12 ed. The bill, as amended, shall be considered as read. All
13 points of order against provisions in the bill, as amended,
14 are waived. The previous question shall be considered as
15 ordered on the bill, as amended, and on any further
16 amendment thereto, to final passage without intervening
17 motion except: (1) one hour of debate equally divided and
18 controlled by the chair and ranking minority member of
19 the Committee on the Judiciary; and (2) one motion to
20 recommit with or without instructions.

21 SEC. 2. Upon adoption of this resolution it shall be
22 in order without intervention of any point of order to con-
23 sider in the House the resolution (H. Res. 326) expressing
24 the sense of the House of Representatives regarding
25 United States efforts to resolve the Israeli-Palestinian con-

1 flict through a negotiated two-state solution. The amend-
2 ments to the resolution and the preamble recommended
3 by the Committee on Foreign Affairs now printed in the
4 resolution, modified by the amendments printed in part
5 B of the report of the Committee on Rules accompanying
6 this resolution, shall be considered as adopted. The resolu-
7 tion, as amended, shall be considered as read. The pre-
8 vious question shall be considered as ordered on the reso-
9 lution and preamble, as amended, to adoption without in-
10 tervening motion or demand for division of the question
11 except one hour of debate equally divided and controlled
12 by the chair and ranking minority member of the Com-
13 mittee on Foreign Affairs.
