Ms. SCANLON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 1140) to enhance the security operations of the Transportation Security Administration and stability of the transportation security workforce by applying the personnel system under title 5, United States Code, to employees of the Transportation Security Administration who provide screening of all passengers and property, and for other purposes; providing for consideration of motions to sus-

pend the rules; and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1140) to enhance the security oper-  
6 ations of the Transportation Security Administration and  
7 stability of the transportation security workforce by apply-  
8 ing the personnel system under title 5, United States  
9 Code, to employees of the Transportation Security Admin-  
10 istration who provide screening of all passengers and prop-  
11 erty, and for other purposes. The first reading of the bill  
12 shall be dispensed with. All points of order against consid-  
13 eration of the bill are waived. General debate shall be con-  
14 fined to the bill and shall not exceed one hour equally di-  
15 vided and controlled by the chair and ranking minority  
16 member of the Committee on Homeland Security. After  
17 general debate the bill shall be considered for amendment  
18 under the five-minute rule. The amendment in the nature  
19 of a substitute recommended by the Committee on Home-  
20 land Security now printed in the bill shall be considered  
21 as adopted in the House and in the Committee of the  
22 Whole. The bill, as amended, shall be considered as the  
23 original bill for the purpose of further amendment under

1 the five-minute rule and shall be considered as read. All  
2 points of order against provisions in the bill, as amended,  
3 are waived. No further amendment to the bill, as amended,  
4 shall be in order except those printed in the report of the  
5 Committee on Rules accompanying this resolution. Each  
6 such further amendment may be offered only in the order  
7 printed in the report, may be offered only by a Member  
8 designated in the report, shall be considered as read, shall  
9 be debatable for the time specified in the report equally  
10 divided and controlled by the proponent and an opponent,  
11 shall not be subject to amendment, and shall not be sub-  
12 ject to a demand for division of the question in the House  
13 or in the Committee of the Whole. All points of order  
14 against such further amendments are waived. At the con-  
15 clusion of consideration of the bill for amendment the  
16 Committee shall rise and report the bill, as amended, to  
17 the House with such further amendments as may have  
18 been adopted. The previous question shall be considered  
19 as ordered on the bill, as amended, and on any further  
20 amendment thereto to final passage without intervening  
21 motion except one motion to recommit with or without in-  
22 structions.

23       SEC. 2. It shall be in order at any time on the legisla-  
24 tive day of March 5, 2020, for the Speaker to entertain  
25 motions that the House suspend the rules as though under

1 clause 1 of rule XV, relating to a measure making supple-  
2 mental appropriations for the fiscal year ending Sep-  
3 tember 30, 2020.

4       SEC. 3. The requirement of clause 6(a) of rule XIII  
5 for a two-thirds vote to consider a report from the Com-  
6 mittee on Rules on the same day it is presented to the  
7 House is waived with respect to any resolution reported  
8 through the legislative day of March 5, 2020, relating to  
9 a measure making supplemental appropriations for the fis-  
10 cal year ending September 30, 2020.
