(2) FERS.—Section 8466 of title 5, United 1 2 States Code, is amended by adding at the end the 3 following: 4 "(d) The Office may not authorize a person to receive payments on behalf of a minor or individual of legal disability under subsection (c) if that person has been convicted of a violation of— 8 "(1) section 8345a or 8466a; 9 "(2) section 208 or 1632 of the Social Security 10 Act (42 U.S.C. 408, 1383a); or 11 "(3) section 6101 of title 38.". 12 SEC. 3. IMPLEMENTATION. 13 Payments.—Section (a) AUTHORIZATION OF 14 8348(a)(1)(B) of title 5, United States Code, is amended by inserting "in administering fraud prevention under sections 8345, 8345a, 8466, and 8466a of this title," after 17 "8465(b) of this title,". 18 (b) REGULATIONS.—Not later than 1 year after the date of enactment of this Act, the Office of Personnel 19 20 Management— 21 (1) shall promulgate regulations to carry out 22 the amendments made by section 2; and 23 (2) may promulgate additional regulations re-24 lating to the administration of the representative

payee program.
