AN ACT

To make technical corrections to the computation of average
pay under Public Law 110–279.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TECHNICAL CORRECTIONS TO COMPUTATION**
2 **OF AVERAGE PAY UNDER PUBLIC LAW 110-**
3 **279.**

4 (a) IN GENERAL.—Section 1(c)(2)(A) of Public Law
5 110–279 (2 U.S.C. 2051(c)(2)(A)) is amended—

6 (1) by striking “For purposes of” and all that
7 follows through “(i) any period” and inserting the
8 following:

9 “(i) TREATMENT OF SERVICE.—For
10 purposes of chapters 83, 84, and 87 of
11 title 5, United States Code, any period”;

12 (2) in clause (i), by striking “; and” and insert-
13 ing a period; and

14 (3) in clause (ii)—

15 (A) by inserting “TREATMENT OF PAY.—
16 For purposes of chapter 87 of title 5, United
17 States Code,” before “the rate of basic pay”;
18 and

19 (B) by striking “the covered” and insert-
20 ing “a covered”.

21 (b) REGULATIONS.—

22 (1) IN GENERAL.—The Director of the Office of
23 Personnel Management shall promulgate regulations
24 to carry out this section.

25 (2) EFFECTIVE DATE.—The regulations pro-
26 mulgated under paragraph (1) shall take effect not

1 later than 180 days after the date of enactment of
2 this Act.

3 (c) APPLICABILITY OF AMENDMENTS.—

4 (1) DEFINITIONS.—In this subsection, the
5 terms “contractor”, “covered individual”, and “food
6 services contract” have the meanings given those
7 terms in section 1(a) of Public Law 110–279 (2
8 U.S.C. 2051(a)).

9 (2) APPLICABILITY.—The amendments made
10 by this section shall apply with respect to—

11 (A) a covered individual who separates
12 from service as an employee of a contractor per-
13 forming services under the food services con-
14 tract before, on, or after the date of enactment
15 of this Act; and

16 (B) each payment to a covered individual
17 under chapter 83 or 84 of title 5, United States
18 Code, made on or after the effective date of the
19 regulations promulgated under subsection (b).
