10	This subtitle may be cited as the "Voter Confidence
11	and Increased Accessibility Act of 2019".
12	SEC. 102. PAPER BALLOT AND MANUAL COUNTING RE-
13	QUIREMENTS.
14	(a) In General.—Section 301(a)(2) of the Help
15	America Vote Act of 2002 (52 U.S.C. 21081(a)(2)) is
16	amended to read as follows:
17	"(2) Paper ballot requirement.—
18	"(A) Voter-verified paper ballots.—
19	"(i) Paper ballot requirement.—
20	(I) The voting system shall require the use
21	of an individual, durable, voter-verified
22	paper ballot of the voter's vote that shall
23	be marked and made available for inspec-
24	tion and verification by the voter before
25	the voter's vote is cast and counted and

1	which shall be counted by hand or read by
2	an optical character recognition device or
3	other counting device. For purposes of this
4	subclause, the term 'individual, durable,
5	voter-verified paper ballot' means a paper
6	ballot marked by the voter by hand or a
7	paper ballot marked through the use of a
8	nontabulating ballot marking device or sys-
9	tem, so long as the voter shall have the op-
10	tion to mark his or her ballot by hand. The
11	paper ballot shall be printed or marked in
12	such a way that vote selections, including
13	all vote selections scanned by voting sys-
14	tems to tabulate votes, can be inspected
15	and verified by the voter without training
16	or instruction or audited by election offi-
17	cials without the aid of any machine or
18	other equipment.
19	"(II) The voting system shall provide

"(II) The voting system shall provide the voter with an opportunity to correct any error on the paper ballot before the permanent voter-verified paper ballot is preserved in accordance with clause (ii).

"(III) The voting system shall not preserve the voter-verified paper ballots in

1 any manner that makes it possible, at any 2 time after the ballot has been cast, to associate a voter with the record of the voter's 3 vote without the voter's consent. Preservation as OFFICIAL 6 RECORD.—The individual, durable, voter-7 verified paper ballot used in accordance with clause (i) shall constitute the official 8 9 ballot and shall be preserved and used as 10 the official ballot for purposes of any re-11 count or audit conducted with respect to 12 any election for Federal office in which the 13 voting system is used. "(iii) Manual counting require-14 15 MENTS FOR RECOUNTS AND AUDITS.—(I) 16 Each paper ballot used pursuant to clause 17 (i) shall be suitable for a manual audit, 18 and shall be counted by hand in any re-19 count or audit conducted with respect to 20 any election for Federal office. 21 "(II) In the event of any inconsist-22 encies or irregularities between any elec-23 tronic vote tallies and the vote tallies de-

termined by counting by hand the indi-

vidual, durable, voter-verified paper ballots

5	"(iv) Application to all bal-

9	cast by absent uniformed services voters
10	and overseas voters under the Uniformed
11	and Overseas Citizens Absentee Voting Act
12	and other absentee voters.
13	"(B) Special rule for treatment of
14	DISPUTES WHEN PAPER BALLOTS HAVE BEEN
15	SHOWN TO BE COMPROMISED.—
16	"(i) In General.—In the event
17	that—
18	"(I) there is any inconsistency
19	between any electronic vote tallies and

21	ing by hand the individual, durable,
22	voter-verified paper ballots used pur-
