## AN ACT

To require review by the Government Accountability Office of screening protocols of the Transportation Security Administration relating to breast milk and formula, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Traveling Parents  
3 Screening Consistency Act of 2019”.

4 **SEC. 2. COMPTROLLER GENERAL REVIEW OF IMPLEMEN-**  
5 **TATION BY TRANSPORTATION SECURITY AD-**  
6 **MINISTRATION OF SCREENING PROTOCOLS**  
7 **RELATING TO BREAST MILK AND FORMULA.**

8 (a) **IN GENERAL.**—Not later than one year after the  
9 date of the enactment of this Act, the Comptroller General  
10 of the United States shall conduct a review of—

11 (1) the implementation by the Transportation  
12 Security Administration (in this section referred to  
13 as “TSA”) of the Bottles and Breastfeeding Equip-  
14 ment Screening Act (Public Law 114–293; 49  
15 U.S.C. 44901 note); and

16 (2) the effectiveness of TSA in ensuring the  
17 clarity of screening protocols relating to, and the  
18 consistency of screening of, breast milk and other  
19 liquids for the consumption of infants, including for-  
20 mula, purified deionized water, and juice.

21 (b) **ELEMENTS.**—The review required by subsection  
22 (a) shall include—

23 (1) an assessment of—

24 (A) whether TSA effectively manages the  
25 consistency of the application of protocols to the

1 screening of breast milk and other liquids de-  
2 scribed in subsection (a)(2);

3 (B) the need for TSA to update and revise  
4 procedures for screening breast milk and other  
5 liquids described in subsection (a)(2);

6 (C) whether TSA effectively tracks pas-  
7 senger complaints related to such screening to  
8 monitor trends and identify inconsistencies;

9 (D) the practices of TSA with respect to  
10 communications and information sharing with  
11 passengers, air carriers, and airports relating to  
12 protocols for such screening; and

13 (E) the policies of TSA regarding the  
14 screening of passengers with nursing products,  
15 including the extent to which such passengers  
16 are more likely to receive secondary screening;  
17 and

18 (2) make recommendations for improving the  
19 practices of TSA relating to such screening.
