## A BILL

To reauthorize The Last Green Valley National Heritage Corridor and the Upper Housatonic Valley National Heritage Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Last Green Valley Na-  
5 tional Heritage Corridor and the Upper Housatonic Valley  
6 National Heritage Area Reauthorization Act”.

1 **SEC. 2. REAUTHORIZATION OF THE LAST GREEN VALLEY**  
2 **NATIONAL HERITAGE CORRIDOR AND THE**  
3 **UPPER HOUSATONIC VALLEY NATIONAL HER-**  
4 **ITAGE AREA.**

5 (a) **LAST GREEN VALLEY NATIONAL HERITAGE**  
6 **CORRIDOR.—**

7 (1) **REAUTHORIZATION.**—Section 106(b) of the  
8 Quinebaug and Shetucket Rivers Valley National  
9 Heritage Corridor Act of 1994 (54 U.S.C. 320101  
10 note; Public Law 103–449; 108 Stat. 4755; 113  
11 Stat. 1728; 123 Stat. 1291; 128 Stat. 3802) is  
12 amended by striking “2021” and inserting “2036”.

13 (2) **REPEAL OF TOTAL FUNDING CAP.**—Section  
14 109(a) of the Quinebaug and Shetucket Rivers Val-  
15 ley National Heritage Corridor Act of 1994 (54  
16 U.S.C. 320101 note; Public Law 103–449; 108 Stat.  
17 4756; 113 Stat. 1729; 123 Stat. 1292) is amended  
18 by striking the second sentence.

19 (b) **UPPER HOUSATONIC VALLEY NATIONAL HERIT-**  
20 **AGE AREA.—**

21 (1) **REPEAL OF TOTAL FUNDING CAP.**—Section  
22 280A(a) of the Upper Housatonic Valley National  
23 Heritage Area Act (54 U.S.C. 320101 note; Public  
24 Law 109–338; 120 Stat. 1819) is amended by strik-  
25 ing the second sentence.

2           Upper Housatonic Valley National Heritage Area  
3           Act (54 U.S.C. 320101 note; Public Law 109–338;  
4           120 Stat. 1819) is amended by striking “15 years”  
5           and inserting “30 years”.
