A BILL

To amend the Servicemembers Civil Relief Act to clarify the authority of servicemembers who incur a catastrophic injury or illness while in military service to terminate leases of premises and motor vehicles, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Leasing Relief for De-
5 pendants of Fallen Heroes and Injured Servicemembers
6 Act of 2020”.

1 **SEC. 2. CLARIFICATION OF TERMINATION OF LEASES OF**
 2 **PREMISES AND MOTOR VEHICLES OF**
 3 **SERVICEMEMBERS WHO INCUR CATA-**
 4 **STROPHIC INJURY OR ILLNESS OR DIE**
 5 **WHILE IN MILITARY SERVICE.**

6 (a) CATASTROPHIC INJURIES AND ILLNESSES.—
 7 Paragraph (4) of section 305(a) of the Servicemembers
 8 Civil Relief Act (50 U.S.C. 3955(a)), as added by section
 9 545 of the National Defense Authorization Act for Fiscal
 10 Year 2020 (Public Law 116–92), is amended to read as
 11 follows:

12 “(4) CATASTROPHIC INJURY OR ILLNESS OF
 13 LESSEE.—

14 “(A) TERMINATION.—If the lessee on a
 15 lease described in subsection (b) incurs a cata-
 16 strophic injury or illness during a period of
 17 military service or while performing covered
 18 service, during the one-year period beginning on
 19 the date on which the lessee incurs such injury
 20 or illness—

21 “(i) the lessee may terminate the
 22 lease; or

23 “(ii) in the case of a lessee who lacks
 24 the mental capacity to contract or to man-
 25 age his or her own affairs (including dis-

1 bursement of funds without limitation) due
2 to such injury or illness—

3 “(I) in a case in which the lessee
4 has a spouse, the spouse may termi-
5 nate the lease;

6 “(II) in a case in which the les-
7 see does not have a spouse but does
8 have an adult dependent, the depend-
9 ent may terminate the lease;

10 “(III) in a case in which the les-
11 see does not have a spouse or an adult
12 dependent, a person who has been
13 granted a power of attorney by the
14 lessee may terminate the lease; or

15 “(IV) in any other case, such
16 other person as a court of competent
17 jurisdiction may appoint to manage
18 the affairs of the lessee may terminate
19 the lease.

20 “(B) DEFINITIONS.—In this paragraph:

21 “(i) CATASTROPHIC INJURY OR ILL-
22 NESS.—The term ‘catastrophic injury or
23 illness’ has the meaning given that term in
24 section 439(g) of title 37, United States
25 Code.

1 “(ii) COVERED SERVICE.—The term
2 ‘covered service’ means full-time National
3 Guard duty, active Guard and Reserve
4 duty, or inactive-duty training (as such
5 terms are defined in section 101(d) of title
6 10, United States Code).”.

7 (b) DEATHS.—Paragraph (3) of such section is
8 amended by striking “The spouse of the lessee” and in-
9 serting “The spouse or dependent of the lessee”.
