A BILL

To amend title 10, United States Code, to provide for the expansion of the Junior Reserve Officers' Training Corps, to expand the Cyber Institutes Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “JROTC and ROTC
5 Enhancement Act of 2020”.

1 **SEC. 2. EXPANSION OF JUNIOR RESERVE OFFICERS' TRAIN-**
2 **ING CORPS PROGRAM.**

3 (a) EXPANSION OF JROTC CURRICULUM.—Section
4 2031(a)(2) of title 10, United States Code, is amended
5 by inserting after “service to the United States” the fol-
6 lowing: “(including an introduction to service opportuni-
7 ties in military, national, and public service)”.

8 (b) PLAN TO INCREASE NUMBER OF JROTC
9 UNITS.—The Secretary of Defense shall, in consultation
10 with the Secretaries of the military departments, develop
11 and implement a plan to establish and support not fewer
12 than 6,000 units of the Junior Reserve Officers' Training
13 Corps by September 30, 2031.

14 **SEC. 3. EXPANSION OF CYBER INSTITUTES PROGRAM.**

15 Section 1640 of the John S. McCain National De-
16 fense Authorization Act for Fiscal Year 2019 (Public Law
17 115–232; 132 Stat. 2310; 10 U.S.C. 2200 note) is amend-
18 ed by adding at the end the following:

19 “(g) REPORT TO CONGRESS.—Not later than Sep-
20 tember 30, 2021, the Secretary of Defense shall submit
21 to the Committees on Armed Services of the Senate and
22 the House of Representatives a report on the effectiveness
23 of the Cyber Institutes and on opportunities to expand the
24 Cyber Institutes to additional select institutions of higher
25 learning that have a Reserve Officers' Training Corps pro-
26 gram.

1 “(h) AVAILABILITY OF FUNDS FOR EXPANSION.—
2 Amounts authorized to be appropriated for the Depart-
3 ment of Defense and available for the Cyber Institutes
4 program under this section shall be available for the ex-
5 pansion of the program in accordance with the report re-
6 quired by subsection (g) after September 30, 2021.”.
