## AN ACT

To amend section 1113 of the Social Security Act to provide authority for fiscal year 2020 for increased payments for temporary assistance to United States citizens returned from foreign countries, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Emergency Aid for  
3 Returning Americans Affected by Coronavirus Act”.

4 **SEC. 2. INCREASE IN AGGREGATE PAYMENTS FOR FISCAL**  
5 **YEAR 2020.**

6 (a) **IN GENERAL.**—Section 1113(d) of the Social Se-  
7 curity Act (42 U.S.C. 1313(d)) is amended by striking  
8 “fiscal years 2017 and 2018” and all that follows through  
9 the period and inserting “fiscal year 2020, the total  
10 amount of such assistance provided during such fiscal year  
11 shall not exceed \$10,000,000.”.

12 (b) **EMERGENCY DESIGNATION.**—

13 (1) **IN GENERAL.**—The amounts provided by  
14 the amendment made by this section are designated  
15 as an emergency requirement pursuant to section  
16 4(g) of the Statutory Pay-As-You-Go Act of 2010 (2  
17 U.S.C. 933(g)).

18 (2) **DESIGNATION IN SENATE.**—In the Senate,  
19 this section and the amendment made by this section  
20 are designated as an emergency requirement pursu-  
21 ant to section 4112(a) of H. Con. Res. 71 (115th  
22 Congress), the concurrent resolution on the budget  
23 for fiscal year 2018.

1 **SEC. 3. LIMIT ON DIRECT CONTACT WITH REPATRIATED IN-**  
 2 **DIVIDUALS DURING COVID-19 EMERGENCY**  
 3 **PERIOD.**

4 During the emergency period described in section  
 5 1135(g)(1)(B) of the Social Security Act (42 U.S.C.  
 6 1320b-5(g)(1)(B)), in providing temporary assistance  
 7 under section 1113 of such Act (42 U.S.C. 1313), no em-  
 8 ployee of the Administration for Children and Families of  
 9 the Department of Health and Human Services shall have  
 10 direct, in-person contact with an individual specified in  
 11 section 1113(a)(1) of such Act (42 U.S.C. 1313(a)(1)),  
 12 except in the case of a uniformed member of the Regular  
 13 Corps or the Ready Reserve Corps of the Commissioned  
 14 Corps of the Public Health Service (as described in section  
 15 203 of the Public Health Service Act (42 U.S.C. 204))  
 16 in an active duty status who, as determined by the Sec-  
 17 retary of Health and Human Services, has—

- 18 (1) received appropriate training on infection  
 19 prevention and control; and  
 20 (2) access to appropriate personal protective  
 21 equipment.
