A BILL

To provide for a report on the maintenance of Federal land holdings under the jurisdiction of the Secretary of the Interior.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REPORT ON MAINTAINING FEDERAL LAND**
 2 **HOLDINGS UNDER THE JURISDICTION OF**
 3 **THE SECRETARY OF THE INTERIOR.**

4 Not later than 120 days after the date on which the
 5 President submits to Congress the budget of the United
 6 States for fiscal year 2020, the Secretary of the Interior
 7 shall submit to Congress a report that describes—

8 (1) all Federal land holdings under the jurisdic-
 9 tion of the Secretary of the Interior; and

10 (2) the total cost of maintaining the Federal
 11 land holdings described under paragraph (1) for
 12 each of fiscal years 2017 through 2019, including an
 13 accounting of holdings and expenditures by each
 14 Federal agency with respect to the land holdings.

15 **SECTION 1. BUREAU OF LAND MANAGEMENT LAND ACQUI-**
 16 **SITION DATA.**

17 *The Secretary of the Interior (acting through the Di-*
 18 *rector of the Bureau of Land Management) shall—*

19 (1) *collect centralized data on land acquired for*
 20 *administration by the Bureau of Land Management*
 21 *using amounts from the Land and Water Conserva-*
 22 *tion Fund established under section 200302 of title*
 23 *54, United States Code, including data on—*

24 (A) *the method used for the acquisition; and*
 25 (B) *the type of interest acquired;*

1 (2) *not later than 1 year after the date of enact-*
2 *ment of this Act, and annually thereafter, submit to*
3 *Congress a report describing the information collected*
4 *under paragraph (1); and*

5 (3) *develop guidance to ensure that land acquisi-*
6 *tion data collected under paragraph (1) is entered*
7 *correctly and properly coded in the data system of the*
8 *Bureau of Land Management.*

Amend the title so as to read: “A bill to require the collection of certain data relating to Bureau of Land Management land acquisitions, and for other purposes.”.
