## A BILL

To authorize the National Medal of Honor Museum Foundation to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Medal of  
5 Honor Monument Act”.

6 **SEC. 2. AUTHORIZATION TO ESTABLISH COMMEMORATIVE**  
7 **WORK.**

8 (a) IN GENERAL.—The National Medal of Honor  
9 Museum Foundation may establish a commemorative work

1 on Federal land in the District of Columbia and its envi-  
2 rons to honor the extraordinary acts of valor, selfless serv-  
3 ice, and sacrifice displayed by Medal of Honor recipients.

4 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-  
5 RATIVE WORKS.—The establishment of the commemora-  
6 tive work under this section shall be in accordance with  
7 chapter 89 of title 40, United States Code (commonly  
8 known as the “Commemorative Works Act”).

9 (c) PROHIBITION ON THE USE OF FEDERAL  
10 FUNDS.—

11 (1) IN GENERAL.—Federal funds may not be  
12 used to pay any expense of the establishment of the  
13 commemorative work under this section.

14 (2) RESPONSIBILITY OF THE NATIONAL MEDAL  
15 OF HONOR MUSEUM FOUNDATION.—The National  
16 Medal of Honor Museum Foundation shall be solely  
17 responsible for acceptance of contributions for, and  
18 payment of the expenses of, the establishment of the  
19 commemorative work under this section.

20 (d) DEPOSIT OF EXCESS FUNDS.—

21 (1) IN GENERAL.—If, on payment of all ex-  
22 penses for the establishment of the commemorative  
23 work under this section (including the maintenance  
24 and preservation amount required by section  
25 8906(b)(1) of title 40, United States Code), there

1 remains a balance of funds received for the estab-  
2 lishment of the commemorative work, the National  
3 Medal of Honor Museum Foundation shall transmit  
4 the amount of the balance to the Secretary of the  
5 Interior for deposit in the account provided for in  
6 section 8906(b)(3) of that title.

7 (2) ON EXPIRATION OF AUTHORITY.—If, on ex-  
8 piration of the authority for the commemorative  
9 work under section 8903(e) of title 40, United  
10 States Code, there remains a balance of funds re-  
11 ceived for the establishment of the commemorative  
12 work under this section, the National Medal of  
13 Honor Museum Foundation shall transmit the  
14 amount of the balance to a separate account with  
15 the National Park Foundation for memorials, to be  
16 available to the Secretary of the Interior or the Ad-  
17 ministrator of General Services, as appropriate, in  
18 accordance with the process provided in paragraph  
19 (4) of section 8906(b) of that title for accounts es-  
20 tablished under paragraph (2) or (3) of that section.
