To designate a mountain ridge in the State of Montana
as “B–47 Ridge”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “B–47 Ridge Designa-
5 tion Act”.

6 **SEC. 2. DESIGNATION OF B–47 RIDGE, MONTANA.**

7 (a) **DESIGNATION.**—

1 (1) IN GENERAL.—The unnamed mountain
 2 ridge located at 45°14'40.89"N, 110°43'38.75"W
 3 that runs south and west of Emigrant Peak in the
 4 Absaroka Range in the State of Montana, which is
 5 the approximate site of a crash of a B-47, shall be
 6 known and designated as “B-47 Ridge”.

7 (2) REFERENCES.—Any reference in a law,
 8 map, regulation, document, paper, or other record of
 9 the United States to the ridge described in para-
 10 graph (1) shall be deemed to be a reference to “B-
 11 47 Ridge”.

12 (b) AUTHORIZATION FOR PLAQUE.—

13 (1) IN GENERAL.—A plaque that memorializes
 14 the crash of the B-47 (including denoting the names
 15 of the victims of the crash) may be installed on B-
 16 47 Ridge.

17 (2) FUNDING.—No Federal funds may be used
 18 to design, procure, install, or maintain the plaque
 19 authorized under paragraph (1).

20 **SECTION 1. SHORT TITLE.**

21 *This Act may be cited as the “B-47 Ridge Designation*
 22 *Act”.*

23 **SEC. 2. DESIGNATION OF B-47 RIDGE, MONTANA.**

24 (a) DESIGNATION.—

1 (1) *IN GENERAL.*—*The unnamed mountain ridge*
 2 *located at 45°14'40.89"N, 110°43'38.75"W that runs*
 3 *south and west of Emigrant Peak in the Absaroka*
 4 *Range in the State of Montana, which is the approxi-*
 5 *mate site of a crash of a B-47, shall be known and*
 6 *designated as "B-47 Ridge".*

7 (2) *REFERENCES.*—*Any reference in a law, map,*
 8 *regulation, document, paper, or other record of the*
 9 *United States to the ridge described in paragraph (1)*
 10 *shall be deemed to be a reference to "B-47 Ridge".*

11 (b) *AUTHORIZATION FOR PLAQUE.*—

12 (1) *IN GENERAL.*—*The Secretary of Agriculture*
 13 *may authorize the installation and maintenance of a*
 14 *plaque on B-47 Ridge that—*

15 (A) *memorializes the 1962 crash of the B-*
 16 *47 aircraft at the site; and*

17 (B) *may include the names of the victims of*
 18 *the crash.*

19 (2) *AUTHORIZED TERMS AND CONDITIONS.*—*The*
 20 *Secretary of Agriculture may include any terms and*
 21 *conditions in the authorization for a plaque under*
 22 *paragraph (1) that the Secretary of Agriculture deter-*
 23 *mines to be necessary.*

1 (3) *FUNDING.*—*No Federal funds may be used to*
2 *design, procure, install, or maintain the plaque au-*
3 *thorized under paragraph (1).*
