3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Students Voicing Opin5 ions in Today's Elections Act" or the "Students VOTE
6 Act".

1SEC. 2. PILOT PROGRAM FOR PROVIDING VOTER REG-2ISTRATION INFORMATION TO SECONDARY3SCHOOL STUDENTS PRIOR TO GRADUATION.

4 (a) PILOT PROGRAM.—The Election Assistance Com-5 mission (hereafter in this Act referred to as the "Commis-6 sion") shall carry out a pilot program under which the 7 Commission shall provide funds during fiscal year 2019 8 to eligible local educational agencies for initiatives to pro-9 vide information on registering to vote in elections for pub-10 lic office to secondary school students in the 12th grade.

(b) ELIGIBILITY.—A local educational agency is eligible to receive funds under the pilot program under this
Act if the agency submits to the Commission, at such time
and in such form as the Commission may require, an application containing—

- 16 (1) a description of the initiatives the agency17 intends to carry out with the funds;
- 18 (2) an estimate of the costs associated with19 such initiatives; and
- 20 (3) such other information and assurances as21 the Commission may require.

(c) CONSULTATION WITH ELECTION OFFICIALS.—A
local educational agency receiving funds under the pilot
program shall consult with the State and local election officials who are responsible for administering elections for

public office in the area served by the agency in developing
 the initiatives the agency will carry out with the funds.
 (d) DEFINITIONS.—In this Act, the terms "local edu cational agency" and "secondary school" have the mean ings given such terms in section 8101 of the Elementary
 and Secondary Education Act of 1965 (20 U.S.C. 7801).
 SEC. 3. REPORTS.

8 (a) REPORTS BY RECIPIENTS OF FUNDS.—Not later 9 than the expiration of the 90-day period which begins on 10 the date of the receipt of the funds, each local educational 11 agency receiving funds under the pilot program under this 12 Act shall submit a report to the Commission describing 13 the initiatives carried out with the funds and analyzing 14 their effectiveness.

(b) REPORT BY COMMISSION.—Not later than the expiration of the 60-day period which begins on the date
the Commission receives the final report submitted by a
local educational agency under subsection (a), the Commission shall submit a report to Congress on the pilot program under this Act.

21 SEC. 4. AUTHORIZATION OF APPROPRIATIONS.

There are authorized to be appropriated such sums as may be necessary to carry out this Act.
