9	Video Connect" means the program of the De-
10	partment of Veterans Affairs to connect vet-
11	erans with their health care team from any-
12	where, using encryption to ensure a secure and
13	private session.

- 6 establish a national protocol for the administration of
- 7 medical examinations for volunteer drivers to participate
- 8 in the program described in paragraph (1).
- 9 "(B) In developing the protocol required by subpara-
- 10 graph (A), the Secretary shall consult with such persons
- 11 as the Secretary determines have an interest in the pro-
- 12 gram described in paragraph (1).
- 13 "(C)(i) The Secretary shall implement the protocol
- 14 by first conducting a one-year pilot program using the pro-
- 15 tocol.
- 16 "(ii) After conducting the pilot program required by
- 17 clause (i), the Secretary shall assess the pilot program and
- 18 make such changes to the protocol as the Secretary con-
- 19 siders appropriate.
- 20 "(iii) After making changes to the protocol under
- 21 clause (ii), the Secretary shall implement the protocol in
- 22 phases during the course of one year.".

1	SEC. 5. COMPTROLLER GENERAL OF THE UNITED STATES
2	REPORT ON TRANSPORTATION SERVICES
3	FOR VETERANS.
4	(a) Report Required.—Not later than one year
5	after the date of the enactment of this Act, the Comp-
6	troller General of the United States shall submit to the
7	Committee on Veterans' Affairs of the Senate and the
8	Committee on Veterans' Affairs of the House of Rep-
9	resentatives a report on the program the establishment of
10	which was facilitated under section 111A(b) of title 38,
11	United States Code.
12	(b) Contents.—The report submitted under sub-
13	section (a) shall include the following:
14	(1) A description of the program described in
15	subsection (a), including descriptions of the fol-
16	lowing:
17	(A) The purpose of the program.
18	(B) The activities carried out under the
19	program.
20	(2) An assessment of the sufficiency of the pro-
21	gram with respect to the purpose of the program.
22	(3) An assessment of the cost effectiveness of
23	the program in relation to alternatives.
24	(4) An assessment of the health benefits for
25	veterans who have participated in the program.

1	(5) An assessment of the sufficiency of staffing
2	of employees of the Department of Veterans Affairs
3	who are responsible for facilitating the maintenance
4	of the program.
5	(6) An assessment, with respect to the purpose
6	of the program, of the number of vehicles owned by
7	and operating in conjunction with the program.
8	(7) An assessment of the awareness and usage
9	of the program by veterans and their families.
10	(8) An assessment of other options for trans-
11	portation under the program, such as local taxi com-
12	panies and ridesharing programs such as Uber and
13	Lyft.
