PUBLIC BILLS AND RESOLUTIONS

Under clause 2 of rule XII,

Mr. GALLEG0 (for himself, Mr. ESPAILLAT, Mr. MCGOVERN, Ms. NORTON, Mr. HUFFMAN, Ms. MOORE, Mr. CROW, Mr. COHEN, Ms. SCHAKOWSKY, Mr. CORREA, and Mr. TED LIEU of California): introduced a bill (H.R. 4226) to provide that certain guidance related to the citizenship of children of Federal employees and members of the Armed Forces shall have no force or effect, and for other purposes; which was referred to the Committee on the Judiciary.
