

available into the 2050 timeframe to serve Veterans.

Importantly, the bill provides more than \$6.22 billion in emergency funding to repair damage from earthquakes, flooding, hurricanes, and tornadoes that affected military installations in 2018 and 2019. China Lake Naval Weapons Station, Camp Lejeune, and Tyndall and Offutt Air Force Bases sustained significant damage in these storms. Without this funding, our national security will suffer as these installations are struggling to fully execute their missions.

In closing, I would like to thank the Subcommittee's Chairwoman for her commitment to our bill and her willingness to work across party and regional lines. I also extend my great appreciation to the Subcommittee's majority staff, Matt Washington, Sarah Young, Jenny Hollrah, Nicole Cohen, and Keihysha Cenord, as well as the Subcommittee's minority staff, Betsy Bina and Kiya Batmanglidj, for their expertise, generosity, and support for America's Servicemen and women and our Nation's Veterans.

I urge my colleagues to support this bill.
