Ms. JACKSON LEE. Madam Speaker, this February we recognize and celebrate the 42nd commemoration of Black History Month.

This month we celebrate the contributions of African Americans to the history of our great nation, and pay tribute to trailblazers, pioneers, heroes, and leaders like the 44th President of the United States and First Lady, Barack Obama and Michelle Obama, respectively; Rev. Dr. Martin Luther King, Jr.; Supreme Court Justice Thurgood Marshall; U.S. Senator Blanche Kelso Bruce; U.S. Congresswoman Barbara Jordan; U.S. Congressman Mickey Leland; Astronauts Dr. Guion Stewart Bluford, Jr. and Mae C. Jemison; activists, intellectuals, authors, artists, and entrepreneurs like Frederick Douglass, Booker T. Washington, James Baldwin, Harriet Tubman, Rosa Parks, Maya Angelou, Toni Morrison, Gwendolyn Brooks, Shonda Rhimes, Ava Duvernay, Oprah Winfrey, and Super Bowl LIV winning quarterback Patrick Mahomes and National Football League Most Valuable Player Lamar Jackson, just to name a few of the countless number of well-known and unsung heroes whose contributions have helped our nation become a more perfect union.

The history of the United States has been marked by the great contributions of African American activists, leaders, writers, and artists.

As a member of Congress, I know that I stand on the shoulders of giants like Shirley Chisolm, John Conyers, JOHN LEWIS, Ronald Dellums, and Barbara Jordan whose struggles and triumphs made it possible for me to stand here today and continue the fight for equality, justice, and progress for all, regardless of race, religion, gender or sexual orientation.

The greatest of these giants to me are Mrs. Ivalita "Ivy" Jackson, a vocational nurse, and Mr. Ezra A. Jackson, one of the first African Americans to succeed in the comic book publishing business.

They were my beloved parents and they taught me the value of education, hard work, discipline, perseverance, and caring for others.

And I am continually inspired by Dr. Elwyn Lee, my husband and the first tenured African American law professor at the University of Houston.

Madam Speaker, I particularly wish to acknowledge the contributions of African American veterans in defending from foreign aggressors and who by their courageous examples helped transform our nation from a segregated society to a nation committed to the never-ending challenge of perfecting our union.

Several years ago about this time, I was honored to join Congressmen JOHN LEWIS and former Congressman Charles Rangel, a Korean War veteran, in paying tribute to surviving members of the Tuskegee Airmen and the 555th Parachute Infantry, the famed "Triple Nickels" at a moving ceremony sponsored by the U.S. Army commemorating the 50th anniversary of the 1964 Civil Rights Act.

The success of the Tuskegee Airmen in escorting bombers during World War II—achieving one of the lowest loss records of all the escort fighter groups and being in constant demand for their services by the allied bomber units—is a record unmatched by any other fighter group.

So impressive and astounding were the feats of the Tuskegee Airmen that in 1948, it helped persuade President Harry Truman to issue his famous Executive Order No. 9981, which directed equality of treatment and opportunity in all of the United States Armed Forces and led to the end of racial segregation in the U.S. military forces.

It is a source of enormous and enduring pride that my father-in-law, Phillip Ferguson Lee, was one of the Tuskeqee Airmen.

Clearly, what began as an experiment to determine whether "colored" soldiers' were capable of operating expensive and complex combat aircraft ended as an unqualified success based on the experience of the Tuskegee Airmen, whose record included 261 aircraft destroyed, 148 aircraft damaged, 15,553 combat sorties and 1,578 missions over Italy and North Africa.

They also destroyed or damaged over 950 units of ground transportation and escorted more than 200 bombing missions.

Johnson, Dorothy Vaughan and Mary Jackson authors Maya Angelou, Toni Morrison, and Gwendolyn Brooks; all of whom have each in their own way, whether through courageous activism, cultural or intellectual contributions, or artistic creativity, forged social and political change, and forever changed our great Nation for the better.

It is also fitting, Madam Speaker, that in addition to those national leaders who contributions have made our nation better, we honor also those who have and are making a difference in their local communities.

In my home city of Houston, there are numerous men and women who are great because they have heeded the counsel of Dr. King who said:

"Everybody can be great because anybody can serve. You only a need a heart full of grace. A soul generated by love."

By that measure, I wish to pay tribute to some of the great men and women who help to make Houston the wonderful, dynamic, vibrant, inclusive, and progressive city that it is.

As we celebrate Black History Month, let us pay tribute to those who have come before us, and pay forward to future generations by addressing what is the number one issue for African American families, and all American families today: preserving the American promise of economic opportunity for all.

Our immediate focus must be to work 'For The People' for job creation, and enacting legislation that will foster and lay the foundation for today's and tomorrow's generation of groundbreaking activists, leaders, scientists, writers and artists to continue contributing to the greatness of America.

OPPOSITION TO S. 3201, THE TEM-PORARY REAUTHORIZATION AND STUDY OF THE EMERGENCY SCHEDULING OF FENTANYL ANALOGUES ACT

Mr. DEFAZIO. Madam Speaker, on January 29, I voted against S. 3201, the Temporary Reauthorization and Study of the Emergency Scheduling of Fentanyl Analogues Act.

Fentanyl, a deadly synthetic drug 50 times more powerful than heroin, is wreaking havoc on Americans across the country. In 2017, there were over 47,000 opioid overdose deaths, and 28,000 of those deaths involved synthetic opioids such as fentanyl. In Oregon, fentanyl use and deaths associated with fentanyl use continue to climb: In 2013, there were 14 related fentanyl deaths in Oregon; In 2018, there were more than 75.

We must to do more to combat this epidemic. We should start with aggressively cracking down on major manufacturers. According to the Oregon-Idaho High Intensity Drug Trafficking Area program, most non-pharmaceutical fentanyl and fentanyl analogues that are available in Oregon are illicitly manufactured—primarily in China, as well as in Mexico—and then imported into the United States.

That's why I am a cosponsor of the Fentanyl Sanctions Act. This legislation would require the imposition of sanctions on drug manufacturers in China who knowingly provide synthetic opioids to traffickers, transnational criminal organizations (such as cartels in Mexico who are known to mix fentanyl with other drugs before trafficking them into the U.S.), and financial institutions that assist such entities. It would also authorize new funding for law enforcement and intelligence agencies to combat the foreign trafficking of synthetic opioids and urge the president to significantly ramp up diplomatic efforts with China and

Mexico to establish multilateral sanctions against foreign synthetic opioid traffickers. I am pleased that this important legislation was included in the National Defense Authorization Act for Fiscal Year 2020 that was signed into law last year.

However, I have strong concerns that S. 3201 will expose more individuals to prosecutions and aggressive federal mandatory minimums for even trace amounts of illicit fentanyl and fentanyl analogues, undermine our progress on bipartisan sentencing reform efforts like the First Step Act, and fail to focus our efforts on combatting major illicit fentanyl manufacturers and traffickers.

We must not arrest our way out of this crisis. This epidemic demands thoughtful legislation from Congress, not a knee-jerk response that is likely to exacerbate troubling trends in federal drug prosecutions and incarceration levels.

Given that S. 3201 will extend the Drug Enforcement Administration's (DEA) emergency scheduling of fentanyl-related substances through May 6, 2021, I hope the committees of jurisdiction use that time to develop a balanced, comprehensive approach that protects public health and safety while addressing fentanyl overdoses and reducing the harm of federal mandatory minimums and overincarceration.

TRIBUTE IN HONOR OF CONGREGATION BETH JACOB ON ITS 90TH ANNIVERSARY

Madam Speaker, we rise today to honor Congregation Beth Jacob of Redwood City, California, as it celebrates its 90th Anniversary of service to Jewish residents living between the cities of San Francisco and San Jose. The founders, Polish and Russian immigrants, were among the many Jews who fled Eastern Europe between 1882 and 1910. The group's first service was attended by 25 members and was held in a member's home.

The Congregation held services in its first synagogue in Menlo Park in 1931. In 1952, the Congregation broke ground for its current facility on Alameda de las Pulgas in Redwood City. In 1979, Beth Jacob suffered a cata-

strophic fire, and the current facility was rebuilt in 1981.

Congregation Beth Jacob's first leader was Kenneth Carlton Zwerin who served for a decade, followed by numerous rabbis and lay leaders. Rabbi H. David Teitelbaum, a distinguished civil rights activist, led Beth Jacob to join the United Synagogue of Conservative Judaism, an affiliation that continued until 2013. Rabbi Nathaniel Ezray, the Congregation's current leader, took the leadership position in 1995.

Beth Jacob, a vibrant and egalitarian Congregation, is widely known and highly regarded for its leadership in progressive actions within the Conservative movement. For many years, women, LGBTQ individuals, people with disabilities and those who are homeless have been active and important within the Congregation.
