ANNIVERSARY OF BIRTH OF SHAIKH MUJIBUR RAHMAN

Mr. LEVIN of Michigan. Madam Speaker, I rise today to recognize the anniversary of the birth of Sheikh Mujibur Rahman, recognized as the "Founding Father" of the nation of Bangladesh.

Sheikh Mujibur Rahman, called "Mujib," is also known as "Bangha Bandu," a title that means "Friend of the Bengal." In recognition of the 100th year since the birth of Sheikh Mujib, the government of Bangladesh is celebrating March 17, 2020 through March 17, 2021 as "Mujib Borsho," or the "Mujib Year."

Sheikh Mujib was born on March 17, 1920, in the province of Bengal, in what was then British India. Just over half a century later, on March 7, 1971, he would call for East Pakistan to become the independent nation of Bangladesh. He was subsequently arrested, but his vision for Bengalis would soon become a reality. Following a brutal war for independence, during which an estimated 300,000 to 3,000,000 people lost their lives, the nation of Bangladesh was born on December 16, 1971. Sheikh Mujib was released from prison and became the first President of Bangladesh, serving in that office from April 17, 1971 to January 12, 1972. In January of 1972, he was elected Prime Minister of the first Parliament of Bangladesh.

In 1975, Sheikh Mujib and most of his family were assassinated. Just two of his daughters, current Prime Minister Sheikh Hasina and Sheikh Rehana, were spared, as they were living in what was West Germany at the time.

The centennial of the birth of the "Founding Father" of Bangladesh, Sheikh Mujib, is deeply meaningful to the people of Bangladesh and to those throughout the world with personal connections to the country. Events are being organized in the United States and around the world to commemorate this historical event. I encourage my colleagues to join me in recognizing those working to honor Bangladesh's history and commemorate this event, including Dr. MD. Rabbi Alam, Convener of Bangabandhu Parishad USA and a resident of my home state of Michigan.

I urge my colleagues to join me in standing with the people of Bangladesh, and those in

Dan jumped into action and using his own Beach Craft Bonanza 6-seater, started the over 200-mile flight to Great Falls to meet the Red Cross at the local airport. He says it was the most precious cargo, aside from his family, he has had on his plane. When he touched down in Malta, he met with hospital staff who transferred the blood to the hospital. His quick delivery of blood saved a life.

For Dan, this is why he went into serving in the Montana Highway Patrol: he wanted to help Montanans. Whether he's on or off duty, as a patrolman, he's called to step up in times of need and that's exactly what he did.

DISABLED VETERANS EDUCATION RELIEF ACT

Mr. SABLAN. Madam Speaker, today, I introduce the Disabled Veterans Education Relief Act, which would reinstate VA education assistance for disabled veterans in vocational rehabilitation and employment (VR&E) training in the event their school closes or courses are disapproved. Section 109 of the Forever GI Bill law extended these protections to students using GI Bill benefits but did not include students using education benefits under the VR&E program. By extending these protections to the over 100.000 veterans who participate in the VR&E program every year, our nation will ensure that all veterans can access relief when their studies are disrupted by school closures or disapproved courses through no fault of their own.

The bill requires the VA to protect VR&E students on the same basis as their counter-

parts using GI Bill benefits as mandated by section 109 of the Forever GI Bill law. These protections include the restoration of benefits for those affected by school closures or the course was disapproved as a result of a modified policy, regulation, or law. In addition, my legislation authorizes the VA to continue paying subsistence allowances to VR&E students through the end of the academic term during which such closure or disapproval occurred. VA will also be required to notify affected students of imminent and actual school closures and inform them how the closure will affect their VR&E benefits.

The Act has the support of the Disabled American Veterans, American Legion, Paralyzed Veterans of America, Veterans of Foreign Wars, Student Veterans of America, AMVETS, Association of the U.S. Navy, Military Officers Association of America, National Military Family Association, and the Enlisted Association of the National Guard of the United States.

The gentleman from Illinois, Mr. BOST, is an original cosponsor of the bill.

I urge my colleagues to support this bipartisan legislation.

Born in 1941, Rev Phillip R. Byrum is a native of Greensboro, North Carolina—son of the late Robert and Margaret Byrum. He attended Greensboro Public Schools and graduated from Greensboro College in 1963 with a degree in philosophy and religion.

He went on to attend the Episcopal Theological School in Cambridge, Massachusetts, graduating in 1966. He was assigned to St. Michael's Church in Tarboro, North Carolina and St. Mary's Church in Speed, North Carolina. He was ordained to the Priesthood on June 24, 1967, at Christ Church in Raleigh, North Carolina.

Father Phil was married to the former Anne Stuart Barnette in 1966. They became parents to two sons, Robert Stuart, born 1968 and John Keith, born in 1970. He is also a proud grandfather of seven grandchildren and greatgrandfather of one.

Father Phil and his family moved to Albemarle, North Carolina in 1969, where he became the Rector of Christ Church. He and his family spent a joyful 22 years in this parish, with both sons attending local schools, and leaving to attend and graduate from University of North Carolina at Chapel Hill.

Serving with passion and humility, Father Phil was a dedicated minister to his congregation and was heavily involved in many facets of community life, as well as the work of the Diocese of North Carolina. For many years, he chaired the Commission on Liturgy and Music, and directed a music and worship camp for children on behalf of the Diocese for 19 years. He also began a long relationship with the Society of St. Margaret in Boston, Massachusetts where he served as a visiting chaplain to the Sisters for many years.

In May 1991, Rev. Byrum accepted a call to become Rector of St. Timothy's Church in Wilson, North Carolina. Shortly after, a temporary assignment stretched into nearly 30 years of

service as Father Phil was asked to serve as priest-in-charge of a historic African American church in East Wilson, St. Mark's Church.

Father Phil completed his service in ministry from St. Timothy's in 2000, and focused his ministry service on St. Mark's, while also serving La Iglesia de la Guadalupana, the Spanish-speaking church officially recognized as a congregation in 1998 and shares St. Mark's facilities. Father Phil devoted his service in ministry at St. Mark's and La Guadalupana until his final retirement in 2020.

Father Phil had the privilege of leading his congregations at St. Mark's and La Guadalupana in serving the community with worship services in English and Spanish and through community outreach programs such as food ministries, tutoring programs, and assistance programs for those facing critical situations in their lives.

On February 29, 2020, Father Phil retired from active ministry and will continue to live in his home community.

After receiving his degree, Dr. Evans spent twenty years within the field of toxicology working as a researcher for government agencies, testifying as an expert witness and training the next generation as a professor. In 1990, Dr. Evans created AIT Laboratories, a toxicology and forensics lab that does testing and research for law enforcement, corporations, government agencies, pharmaceutical companies, hospitals, physicians, pain management professionals, medical examiners, attorneys, and courts of law. He went on to serve as the president and CEO until 2012. In 2012, Dr. Evans created AIT Bioscience which is an integrated bioanalytical contract research organization (CRO), supported by a state-of-the-art electronic laboratory environment. Dr. Evans' work is a testament to his passion for science and creating services that help people. He was decorated with honors and awards including a Distinguished Eagle Scout Award, the Distinguished Hoosier and he received the Sagamore of the Wabash Award from the Indiana Governor. Most of the time they hid within shack, but if there were passersby, the family crouched within the hole, breathing from air provided by a tube.

As the war progressed, the German gestapo began to round people up for executions. Searching for a new place to hide his family, Esther's father was shot. Her mother was stricken with grief after her father's death, and as an eight-year-old child, Esther took on the responsibility of convincing her mother and younger sister to keep fighting for survival.

I launched a Constituent of the Month program to recognize individuals who have gone above and beyond to make our region and our country a stronger place for everyone to live and thrive. Ms. Sterling's perseverance and triumph during a time of great danger and divide is not only inspiring, but encouraging. INTRODUCTION OF THE LEADER-SHIP INSTITUTE FOR TRANS-ATLANTIC ENGAGEMENT (LITE) ACT

Mr. HASTINGS. Madam Speaker, I rise today to introduce the Leadership Institute for Transatlantic Engagement (LITE) Act—a bill that will create an institute to assist in strengthening ties with our allies, protect democratic institutions, and support visionary leadership on both sides of the Atlantic.

In the 116th Congress, under my leadership as chair, the Commission on Security and Cooperation in Europe, also known as the U.S. Helsinki Commission, has held events on the importance of international election observation, good governance, and focused on democratic backsliding in particular countries as part of our continued commitment to the underlying principles of the Helsinki Final Act adopted by the 57 North American, European, and Eurasian countries that make up the region of the Organization for Security and Cooperation in Europe (OSCE).

We identified numerous challenges in western leadership that are putting our democracies and the transatlantic partnership at risk, including as continuing disparities in wealth, health, employment, education, justice, and other sectors that lead citizens to question whether democracy can deliver. Common to among these issues is the role leaders can play in ensuring laws are equitable, transparent, and enforced; elections are free and fair; and laying the groundwork to ensure the same protections, rights, and laws, are extended to all in their constituencies.

The LITE Act will establish an institute to assist western democracies in living up to these ideals and restoring faith in democracy, by equipping transatlantic policymakers with legislative, communications, conflict resolution and other leadership tools to strengthen democratic institutions in their societies and the transatlantic relationship. Given demographic change on both sides of the Atlantic, the activities of LITE, as established by this legislation, will also include a focus on inclusive and intergenerational solutions to current challenges with the goal of empowering individuals across generations and from diverse backgrounds with the knowledge, tools, opportunity, and access to fully participate in their democracies. In addition, LITE will seek to reunify communities by assisting leaders with strategies that build resilience against the exploitation of community grievances that can lead to dangerous divisions in our societies.

In February, we hosted young parliamentarians from the OSCE region here in the U.S. Congress to discuss how we can strengthen their political inclusion to advance peace and security efforts. Last year, we held hearings featuring European lawmakers, and on global leadership, democracy and public diplomacy. These hearings were the capstone in a decade of events that began in 2009 whereby the Commission has convened U.S. and European policymakers under the banner of the Transatlantic Minority Political Leadership Conference and Transatlantic Inclusion Leaders Network to support increased political representation in western democracies. As we celebrate the tenth anniversary of these efforts that have been pivotal in strengthening international relations over the past decade, I hope you will join me in supporting LITE to further codify leadership exchanges and knowledge building between diverse and young transatlantic policy makers as a means to sustain our democratic futures.

Ms. NORTON. Madam Speaker, today, I introduce the Major General David F. Wherley, Jr., District of Columbia National Guard Retention and College Access Act (NGRCA). This bill is named for General Wherley, former Commanding General of the D.C. National Guard, who, along with his wife, Ann, and seven others were tragically killed when Metro trains collided on the Red Line on June 22, 2009. This bill would permanently authorize funding for a program that provides grants for higher education to members of the D.C. National Guard, which is under the control of the federal, not the District of Columbia, government. I renamed this bill after General Wherley because he worked tirelessly with me to get funding for the program for many years, and because of his devotion to the youth of the District and to the National Guard.

The NGRCA authorizes an education incentive program, recommended by General Wherley and his successor, Major General Errol Schwartz, to stem the troublesome loss of D.C. Guard members to other units, including National Guards in surrounding states that offer such educational benefits to their Guards. I am grateful that Congress has consistently provided funds for the program at our request, most recently \$413,000 in fiscal year 2020. Permanently authorizing the program is necessary, however, to ensure that D.C. Guard members receive the same treatment and benefits as other National Guard members, particularly those in neighboring states that compete with the District for members and provide these education benefits. Today, the Guard for the nation's capital has a diminished ability to compete for regional residents if membership in the Maryland or Virginia Guards is more economically beneficial. A competitive tuition assistance program for the D.C. Guard would provide a significant and much-needed incentive to help maintain enrollment and level the field of competition. The federal government supports D.C. Guard functions and understands it should support this small benefit as well, because the appropriators have always funded the D.C. Guard program, even without authorization. However, depending on appropriations alone leaves the D.C. Guard program in a tenuous condition at odds with the tuition programs in nearby states. Because the program is not controversial, there is no reason not to permanently authorize funding for these D.C. National Guard education benefits.

I appreciate that the appropriators and ultimately Congress have not hesitated to fund the education benefits for the D.C. National Guard. This support argues strongly for permanent authorization. These small education benefits have not only encouraged high-quality recruits, but have helped the D.C. Guard to maintain the force necessary to protect the federal presence here, including the possibility of a natural disaster or terrorist attack. I am pleased to introduce this bill based on the adis necessary.

I urge my colleagues to support this bill.

THE VOICE OF THE MARTYRS

This Saturday, February 29 (it is a leap year), is the anniversary of the arrest and imprisonment of Richard Wurmbrand in 1948. Born in Bucharest, Romania, in 1909, Richard was sent to Moscow as an adolescent to study Marxism. He was pursued by the Soviet secret police, and upon his return to Romania, he became a Comintern for the communist regime. At the outbreak of the second World War, he was converted to Christianity and was later ordained, first as an Anglican and then, as the war was almost over and his country occupied by the Soviet Union, a Lutheran. In 1944, he began a ministry to his Romanian countrymen and to Red Army soldiers. As the Soviet regime began to control churches, Wurmbrand began an "underground" ministry to his people. Within a few years, he denounced communism as incompatible with Christianity. He was arrested on February 29, 1948, while on his way to church.

Richard Wurmbrand passed through several penal facilities and would spend three years in solitary confinement, twelve feet below ground without light or sound (the guards put felt under their shoes). He later recounted that he maintained his sanity by sleeping by day and staving awake at night preaching out loud a sermon to himself.

Wurmbrand was released from prison in 1956 after eight and half years. Warned not to preach again, he continued to serve the underground churches and was arrested again in 1959 and sentenced to 25 years. During this second imprisonment, he was beaten and tortured, including mutilation, burning, and being locked in a freezer icebox. Later, he recounted how his feet were beaten until the flesh was exposed, and then the next day beaten until the bones were exposed.

In 1964, Norwegians paid the Communist for his release, and regime \$10,000 Wurmbrand and his wife would eventually emigrate to the United States. He died in 2001 in California.

During his time in the United States he authored almost 20 books and founded The Voice of the Martyrs, an organization that draws attention to the persecuted church worldwide.

Here is one of Wurmbrand's famous quotes: "I have seen Christians in Communist prisons with fifty pounds of chains on their feet, tortured with red-hot iron pokers, in whose throats spoonfuls of salt had been forced, being kept afterward without water, starving, whipped, suffering from cold-and praying with fervor for the Communists. This is

My bill calls for a government-wide diversity and inclusion plan that ensures that all branches of government are engaged in multi-year strategic planning that recruits, hires, promotes, retains, and supports leadership from America's diverse talent pool in the federal workforce for the good of our country. It also calls for a review of diversity in government contracting and grantmaking, as both are often also pathways to government jobs.

Diversity and inclusion are the underpinnings of democratic societies. It is time that we enforce democratic values by ensuring all segments of our society have equal access and opportunity to contribute to a vibrant workforce that is at the heart of our democracy for the future of our nation.
