By 90 yeas to 10 nays (Vote No. 133), Inhofe Amendment No. 2411 (to Amendment No. 2301), to impose additional conditions and limitations on the transfer of Department of Defense property for law enforcement activities. (Pursuant to the order of Thursday, July 2, 2020, the amendment having achieved 60 affirmative votes, was agreed to.)

Inhofe (for Shaheen) Amendment No. 1729 (to Amendment No. 2301), to increase funding for the study by the Centers for Disease Control and Prevention relating to perfluoroalkyl and polyfluoroalkyl substance contamination in drinking water. By 96 yeas to 4 nays (Vote No. 134), Cornyn Amendment No. 2244 (to Amendment No. 2301), to restore American leadership in semiconductor manufacturing by increasing federal incentives in order to enable advanced research and development, secure the supply chain, and ensure long-term national security and economic competitiveness. (Pursuant to the order of Thursday, July 2, 2020, the amendment having achieved 60 affirmative votes, was agreed to.) **Pages S4326–30**

that, according to the preliminary results of the Special Election held June 23, 2020, the Honorable Chris Jacobs was elected Representative to Congress for the Twenty Seventh Congressional District, State of New York. **Page H3595**

Whole Number of the House: The Speaker announced to the House that, in light of the administration of the oath to the gentlemen from New York, the whole number of the House is 431. **Page H3596**

William M. (Mac) Thornberry National Defense Authorization Act for Fiscal Year 2021: The House passed H.R. 6395, to authorize appropriations for fiscal year 2021 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, by a yea-and-nay vote of 295 yeas to 125 nays, Roll No. 152. Consideration began yesterday, July 20th. **Pages H3598–H3607**

Rejected the Green (TN) motion to recommit the bill to the Committee on Armed Services with instructions to report the same back to the House forthwith with an amendment, by a yea-and-nay vote of 201 yeas to 219 nays, Roll No. 151.

Pages H3603–06

Agreed to amend the title so as to read: “To authorize appropriations for fiscal year 2021 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes.”

Agreed to:

DeGette amendment (No. 7 printed in H. Rept. 116–457) that was debated on July 20th that adds the text of H.R. 2546, the Protecting America’s Wilderness Act (by a yea-and-nay vote of 234 yeas to 179 nays, Roll No. 146);

Page H3600

Neguse amendment (No. 8 printed in H. Rept. 116–457) that was debated on July 20th that adds the text of H.R. 823, the Colorado Outdoor Recreation and Economy Act to the bill and withdraws, permanently one million acres of public land surrounding Grand Canyon National Park that are already (as of 2012) subject to a 20-year moratorium on new mining claims (by a yea-and-nay vote of 234 yeas to 181 nays, Roll No. 147);

Dean amendment (No. 11 printed in H. Rept. 116–457) that was debated on July 20th that provides up to \$10,000 in immediate assistance to pay down the balance of private student loans (by a yea-and-nay vote of 217 yeas to 198 nays, Roll No. 149); and

Takano amendment (No. 29 printed in H. Rept. 116–457) that was debated on July 20th that closes a federal loophole by making military education benefits such as Department of Defense Tuition Assistance count as federal educational assistance funds and limits the availability of federal funds for proprietary for-profit institutions unless the institution derives at least 10% of funds from sources other than federal funds (by a yea-and-nay vote of 232 yeas to 184 nays, Roll No. 150).

Pocan amendment (No. 9 printed in H. Rept. 116–457) that was debated on July 20th that sought to reduce overall authorization level by 10% (by a yea-and-nay vote of 93 yeas to 324 nays, Roll No. 148).
